

### STATUS OF JHARIA MASTER PLAN DOVETAILED WITH ENVIRONMENT CLEARANCE CONDITIONS

### Rehabilitation and Fire control measures

### Socio-economic Survey:

Out of total 595 nos. of fire affected / subsidence prone sites / areas to be surveyed, CIMFR, ISM, whiz Mantra and JRDA have completed demographic / socio-economic survey of 369 sites in which 39502 families have been identified. Photo Identity Cards (PICs) are completed for 24076 families till 31.05.2013.

### Accommodation provided in Satellite Township:

- 2352 houses have been constructed in Belgoria rehabilitation Township "Jharia Vihar" in which
   1161 fāmilies have shifted till 31-05-2013. Progress is very slow since July, 2012.
- 1137 nos. of affected families have each been handed over cheque amounting to Rs.10,000/- as shifting allowance.
- 1041 nos. of families have been given 1<sup>st</sup> & 2<sup>nd</sup> payment of minimum wages of 250 days, whereas 299 nos. of families have been given 3rd & 4th last instalment totalling to 500 days.
- As decided in 4<sup>th</sup> HPCC meeting, revised updated cost estimate of Master Plan as on April, 2011 was prepared by CMPDI, after incorporating BSUP housing provision under JNNURM norms for encroachers (carpet area enhanced from 18.9 sq.m. to 25.10 sq.m.). This was accepted in JRDA Board and was sent to MoC for kind approval on 2nd April, 2012. The proposal for enhancement of the area has been moved by MoC to Cabinet Committee of Infrastructure (CCI) for approval on 11-10-2012, which have been approved on 10 th Jan 2013 and communicated on 21-02-13.
- E-tender for 2000 units BSUP Houses under JNNURM norms (Carpet area 25.10 sqm) has been floated by JRDA on 9.12.2011. Tender is opened on 16.01.12. Price bid opened on 21.02.2012. Letter for acceptance has been issued to M/s INDU PROJECTS LTD. Hyderabad by JRDA vide letter No.365, dated 6.9.2012 for awarded value of Rs.70.11 crores. Work has been started by the agency on 18.02.2013. Foundation works in 30 Blocks are in progress. Physical progress of the work is 2.5%

JRDA is unable to shift non-BCCL persons/ encroachers from endangered and fiery zones under the approved Master Plan, due to non-availability of houses / land for rehabilitation. BCCL has decided to temporarily shift those persons (whose socio-economic survey has been done by JRDA) to 'Reclaimed Sites' in various collieries of BCCL. For the purpose, BCCL has already selected 47.84 Acres land in non-fire zones

Position of acquisition of land by JRDA for rehabilitation sites:

- About 1105 ha. of land (say 2730 Acres) would be required for resettlement of non-BCCL families.
- Proposals for acquisition of 1038.88 acres of Raiyati land have been sent to the DLAO, Dhanbad by
- Proposal for acquisition of 274.44 acres of Government land have been sent to the Addl. Collector,
- 440 acres of Raiyati as well as Govt. land have been surveyed for acquisition / transfer by JRDA.
- Delivery of possession for mouza Lipania (120.82 acres Raiyati land) and Dhokra (Ring road 7.99 acres Raiyati land and 1.35 acres Govt. land) has been taken over by JRDA from DLAO, Dhanbad on

Delivey on possession for mouza duhatand- 5.12 Acre, Manaitand – 2.33 Acre and Dhanhad- 4.76 Acre has been taken over by JRDA from DLAO, Dhanbad on 15.04.13 Transfer of land to JRDA by BCCL:

86.44 acres of vacant land in Bhuli Township and 849.68 acres of non-coal bearing land in and around Belgoria Township belonging to BCCL have been identified for developing new Townships by JRDA. NOC for transferring the land to JRDA has been given by MoC which has been communicated to JRDA vide letter no. D(T):OP:F-24/11/502 dated 30.09.11/3.10.11. BCCL has provided all the required mouza plans with details to JRDA vide letter no. 944, dated 16.12.2011 and No.964, dated 17.12.2011 In response to letter no.365, dated 27.5:13 issued by DC-cum-Project Director, JRDA, BCCL proposed one time dispensation for release of 372 employments for physical possession of entire land for which NoC has been given to JRDA. Said proposal is agreed by BCCL Board and also forwarded to CIL for obtaining permission from MoC, Govt. of India.

# Road diversion from fire affected areas:

A DPR for strengthening / widening of Mahuda –Topchanchi road as short term measure, duly prepared by RITES, has been approved by Secretary, Road Construction Deptt., Govt. of Jharkhand, who in turn has asked BCCL to submit Rs.19.86 crores for the same. BCCL has provided the amount to JRDA on 25.02.2012 and they have deposited the amount to Executive Engineer, RCD, Dhanbad on 14.3.2012. RCD have finished 45% of job with fund utilisation of Rs.7.00 Cr. Earth work and GSB upto 17 km. is completed. WBM completed upto 8.0 km.

DPR for construction of road from Joraphatak to Dhokra, for connectivity of Belgoria Township was forwarded to RCD, Govt. of Jharkhand on 13.2.2012 by JRDA for technical sanction. Work has been awarded by RCD, Dhanbad, which is likely to start shortly

# Rail Diversion from fire affected places:

RITES had submitted the discussion plan on the above subject to JRDA on 8.9.2010. BCCL's observations had been sent to JRDA on 30.11.2010. In this regard, E.C. Railway, Hazipur and S.E. Railway, Kolkata had also forwarded the brief report along with their comments to Railway Board,

New Delhi. A meeting was held on 27.4.2012 in the office of C.O.M., E.C. Rly., Hajipur, After discussions in length, it was agreed by E.C. Rly. to send their report soon to Railway Board, New Delhi. Some comments were asked by C.O.M., E.C.Rly., Hajipur and reply was sent to them on 25th July, 2012.East- Central Railway, Hajipur has sent his consent to Railway Board on 14.02.13 along with their suggestions.

On the other hand, directions have been issued to RITES Ltd. by D.C.-cum-Project Director, JRDA for traffic survey and data collection to initiate feasibility study regarding Diversion of Railway lines from fire affected and subsidence prone areas. RITES has floated tender for detailed feasi bility reports of proposed Railway alignment.

# **Utility Services Diversion from the fire affected areas:**

- Discussion Plan and Brief Report for proposed diversion of Utility Services has been prepared by RITES on 07.01.2011. BCCt issued clearances to JRDA on 22.03.2011 for electrical and telecom portion and on 19.5.2011 for water supply portion.
- JRDA had asked RITES Ltd. to start the survey work and prepare a detailed project report (DPR) on
- Survey work of utility services is in progress from last week of June, 2012 by RITES Ltd. Feasibility Report for diversion of utility service of Jharia Coalfield has been submitted by RITES Ltd. on

### Service building:

- Tender for providing boundary pillars for 90 acres of land at Belgoria has been invited and LOA has been issued by JRDA on 25.08.2012 for Rs.2,32,826/-. Work has been started on 6.9.2012. Concrete pillars are ready but erection could not be done due to land problem. JRDA has issued LOA for construction of high school at Belgoria vide no.326 dated 17.05.13 in favour of M/S NDC&NECCPL(JV) for the cost of Rs.3.61 crore for the completion period of 15 months. Construction work is started by the agency
- Construction work of Market Complex, Bank & Post Office at Jharia Vihar, Belgoria has been completed and ready for allotment. A committee has been constituted by DC-cum- Project Director JRDA for allotment of shops at Belgoria.
- BCCL has provided Health Sub-Centre, Community Centre, Atta Chakki at Belgoria Township for
- LOA for construction of Temple at Belgoria has been issued. But contactor did not turn up to start the work. His EM Deposit was forfeited and retender was called on 26.02.2013. LOA has been issued by JRDA on 25.04.13. Work is also started by the agency.

- Work for construction of Masjid at Belgoria has been issued to M/S Om Prakash Singh for the value of Rs. 16.77 Lacs and 5% job is completed.
- JRDA has issued LOA for construction of boundary wall around Children Park at Belgoria to M/S Raj Construction for the value of Rs. 12.21 Lacs and 2% job is completed.
- JRDA has selected 62 rehabilitated persons from Belgaria Township for imparting training at ITI Dhanbad under CSR activities of BCCI for which BCCL has already paid Rs.2,49,300/- to JRDA. Training of 26 persons has been started in 1<sup>st</sup> Phase.
- BCCL has released Rs.3.37 Cr. to JRDA on 31.03.2012 for strengthening of road from Barmasia to Jharia-Baliapur road junction via Belgaria Township, for better connectivity to rehabilitated persons under CSR activity. JRDA has obtained technical sanction for Rs.3.50 Cr. (approx.) on 14.05.2012. Work has been started by Rural Works Deptt. (RWD) and 28% work is completed.
- BCCL has constructed Computer and Sewing Training Centre at Jharia Vihar, Belgoria for the cost
  of Rs. 6.67 lakhs.
- BCCL has constructed Administrative Block at Jharia Vihar, Belgoria for the cost of Rs.3.84 lakhs. Drain clearing work in Jharia Vihar, Belgoria is completed
- (i) Welfare Programme:

Various welfare training and employment generation programmes are being organised with the help/aid of Nari Shakti of BCCL for rehabilitated families at Belgoria Townships viz.

- (i) Distribution of 14 Rickshaws, 8 business tri-cycles, 8 tricycles, 6 wheel chairs and 5 baishakhis to the needy persons.
- (ii) 1500 blankets were distributed in winter seasons.
- (iii) 80 women are getting stitching training in 4 batches.
- (iv) Adult education programme are also being conducted. 60 persons are covered uptill now.
- (v) A Self Help Group comprising of ladies of nine families headed by Kanak Lata Singh is making paper pouches from the donated old newspapers of BCCL township at Belgoria. They prepare about 250 kg. paper pouches in the month and sell at the rate of Rs.20/- per kg earning Rs.5000/- per month.
- (vi) 2000 study materials viz. note-books, pencils, pens, erasers have recently been distributed to the rehabilitated students to promote education amongst them.

An MoU has been signed on 20.03.2013, followed by an agreement on 15.04.2013 between BCCL and CIDC for engaging Construction Industry Development Council (CIDC), New Dolhi for employment linked training programme in construction sector etc. for project affected persons (PAPs) using CSR funds. It is a programme that around 5000 (Five thousands) persons shall be given training through CIDC in the year 2013-14. The MoU and Agreement have been approved by BCCL Board of Directors

# Shifting of BCCL employees residing in fire affected areas:

- (b) For this purpose, 344 houses have been built in non-coal bearing zone.
- (c) 1152 triple storied quarters (96 Blocks each of 12 units) have been constructed at various places in non-coal bearing zone of Kusunda, Katras and Lodna. Development works like External drainage, Road, Retaining walls and Boundary wall have been started at various construction sites. Board of Directors of BCCL has approved Deviation Statement for the addional value of
- (d) BCCL Board has approved construction of 4080 triple storied quarters (340 Blocks each of 12 units). These quarters have also been planned to be constructed in non-coal bearing area at Kusum Vihar & Jagjivan Nagar in addition to Karmatand, Karmik Nagar and Alakdih. The work order has been issued to M/s KCPL and VCL (JV), Bokaro on 22/ 23.12.2011 for the value of Rs.165.56 Crores. Work has already been started by the agency at Kusum Vihar, Jagjivan Nagar and Karmik Nagar.
  - Roof of ground floor of 182 (one hundred eighty two) blocks have been casted.
- Roof of 1<sup>st</sup> floor of 122 (one hundred twenty two) block has been casted.
- Roof of 2<sup>nd</sup> floor of 100 (one hundred) block has been casted.
- Inside plastering in 80 (eighty) blocks has been completed.
- Flooring in 38 (Thirty eight) blocks has been completed.
- Door window in 102 (one hundred two) blocks has been completed.
- Outside plastering in 48 (forty eight) blocks has been completed.
- Expenditure made for the work is Rs.55.83 Cr.

A proposal for construction of 4020 triple storied quarters (335 Blocks each of 12 units) has been made. These quarters have been planned to be constructed in non-coal bearing area at Karmatand Township under Bastacolla Area, Govindpur Area, Lodna Area, EJ Area and CV Area. Tender has been called *and price bid opened on 02.04.2013*. Tender committee recommendation placed in 296<sup>th</sup> Board of Directors of BCCL on 20.04.13. Board has accorded approval for the said tender in favour of M/S unity KCPL (JV) for Rs. 287 Crore. Letter of acceptance has been issued vide no. BCCL/CED/GM(C)/LOA-10/2013-14/253 dated 29/30.05.13

### Status of fire dealing:

Under Master Plan, total 28 nos. of Fire schemes have been proposed in Phase-I to be formulated / prepared for dealing with 67 fires sites spread in 41 collieries. Till date 11 fire schemes have been approved by Board and implemented, out of which 4 nos. of schemes have been completed and rest are under different stages of execution. Three more fire Schemes are under preparation at CMPDIL. Further for expediting the fire dealing process, excavation methods has been resorted to by dieploying. Hired HEMM at

various mines of BCCL. For this, the expenditure is being made from its own revenue budget.

BCGL approached NRSC for conducting fresh survey of fires and subsidence by remote sensing methods in January 2013.NRSC has sent the proposals for coal fire mapping of Jharia coalfield using thermal infra-red data for the cost of Rs.6,70,721.00 and land subsidence mapping of Jharia coalfield using Inter-ferometic SAR data for a cost of Rs. 12,98,571.00. As an advance action, BCCL has approved both the proposals and requested NRSC to submit invoice for Rs. 17.73 lacs (90% of the total cost) vide letter no BCCL/HOD (Env.) /F-MP/610 dated 21.05.13.

A MoU is to be entered with the NRSC for start of the work. For this purpose, duly signed MOU from our end has been sent to NRSC for necessary processing at their end and to start the work immediately. Meanwhile NRSC is mobilising the scientists and other preparatory work to start the survey.

Against the earmarked amount of Rs.2311 crores, an amount of Rs.16 crores has been disbursed to BCCL for control of fires. Now an amount of Rs.2295 crores remains under the approved Jharia Master Plan unspent for fire control measures.

It is proposed by BCCL vide letter no.BCCL/CMD/Sr.ES/F-2(A)/12/274, dated 2<sup>nd</sup> Aug., 2012 that this amount of Rs.2295 crores can be re-appropriated till the RE crosses the amount for facilitating the following various activities for implementation of rehabilitation of families from endangered areas as per the approved Master Pian:

- (a) in enhancing the size of the rehabilitation houses / carpet area from Indira Awas Yojana type to JNNURM housing norms.
- (b) in meeting the financial impact on account of increase in the number of endangered families after actual demographic survey.
- (c) in meeting the appreciation of price of land acquisition etc.

This will enable in accelerating in the implementation of Jharia Master Plan.

# 3. CSR ACTIVITIES OF BCCL

Bharat Coking Coal Limited (BCCL) is committed to good corporate citizenship and makes constant efforts to build and nurture long lasting relationships with members of the society in general and it's peripheral communities in particular.

BCCL is taking up activities from the HQ level and through its administrative areas for the implementation of CSR activities. For this purpose A CSR cell is functioning which is headed by General Manger(Welfare) under the direct control of Director(Personnel) of the company.

The CSR activities are specific to the village, depending on the need assessed for the people by local Hon'ble M.Ps and M.L.As. Further as suggested by the MOEF Committee, a detailed project specific CSR Action Plan shall be formulated and for this purpose, BCCL has approached TATA INSTITUTE AND SOCIAL SCIENCES, MUMBAI which is also the focal agency of the National CSR Hub. CSR Action Plan shall be formulated for the whole Jharia Coalfield and also project-wise which will include need-based/ stakeholder base line survey, monitoring, evaluation, auditing, etc.

# The CSR activities presently being done by BCCL

- To meet the acute shortage of drinking water in peripheral villages' drinking Water
  is provided through deep borewells, tubewells, pumps/motors, in the peripheral
  villages of BCCL. Water supply through pipeline, through water tanker is provided
  also to the villages.
- Education: BCCL adopts a multi=pronged approach to promote quality education in backward areas. The measures taken by BCCL comprise Construction, Extension, and Renovation of school buildings etc are done to promote quality education in the nearby villages. BCCL is Extending financial aid for educational facilities to 83 nos. Private Committee Managed schools. Measures are taken to promote women literacy and carrier development.
- Health Care: BCCL Conducts medical/health camps for dwellers of peripheral
  villages for rendering free medical consultancy. CSR Clinics, wellness clinics,
  artificial limbs centers are organized for the benefit of the needy section of the
  society. Mobile medical vans are deployed as special arrangement for medical
  services. AIDS awareness camps are organized as special drive to develop
  awareness and to render free consultancy.
- Occupational health: awareness programme are organized.
- Other Welfare Activities: this includes Construction / renovation of Community
  Halls, construction / repair of roads, construction of Health-sub centres,
  construction of drain, construction of Chhat Ghat in the ponds, Construction of
  Boundary wall, providing Choupal for community gatherings, Installation of road
  side Water Kiosks during summer etc.
- Mashla Chakki centres: Mashla Chakki centres are established with machines to promote self employment.
- Blankets: During winter, Blankets are distributed among poor section of the society.

- Sports & Cultural: Various activities are organized to propagate sports and cultures. Sports/games items and instruments are also provided. To promote
- Village adoption: Lahbera A SC/ST village in Dhanbad has been adopted for its all round development and a number of development activities have been carried
- Skill development training programs by BCCL for Project Affected persons, fire affected persons and nearby communities: Bharat Coking Coal Limited (BCCL) has signed a Memorandum of Understanding with Construction Industry Development Council (CIDC), New Delhi, a body promoted by Planning Commission, on 20.03.2012 for employment linked training program in the Construction Sector for persons and downtrodden people of the Jharia coalfield including project affected the project affected persons to undergo the required training programs to be conducted by CIDC.

In this regard BCCL will bear the training cost @ Rs.42960/ per candidate which includes all expenses including lodging and boarding and after training the CIDC has to ensure a minimum of 75 % of sustainable placement for a period of six months. In case of placement below 75%, pro rata payment is to be made: All training are mandatorily residential. In the year 2012-13 5000 youths will be trained and in the subsequent years no. Of trainees will be scaled up @ 15% per annum.
