- **1.** Brain storming sessions / safety drive conducted in each Area from **16.05.2016 to 08.06.2016** for discussing the causes and circumstances attaining fatal & serious accidents and suggesting remedial measures.
- **2.** Structured training to Front Line Supervisors has been imparted from **13.06.2016 to 17.06.2016** at HRD Department of BCCL.
- **3.** To reverse the trend of accidents, **Safety Awareness Seminar** in one colony of each area of BCCL involving **family members of workmen** to make aware of advantage of wearing of **PPE** and other safety gadget by workmen and also not consuming alcoholic products during duty period has been scheduled from 25.06.2016 to 10.09.2016. This **SURAKSHA CHAUPAL** was held on **25.06.2016**, **09.07.2016**, **30.07.2016**, **06.08.2016**, **13.08.2016**, **20.08.2016**, **27.08.2016 06.09.2016& 02.12.2016** in Nichitpur Colony of Sijua Area , Adarsh Gram of Bastacolla Area , Coal Dump Colony (GKKC) of Kusunda Area , Coal Dump Colony of Katras Area , AdarshSharmik Colony of PB Area , MOCP Colony of Lodna Area &Muraidih Colony of Barora Area , River Side Colony of EJ Area Laikadih of CV Area and Matigarha Colony of Block-II Area respectively in which response from workmen and their family member was tremendous.
- **4.** Message through **WhatsApp** among group member is regularly sent to all concerned indicating **unsafe practices and unsafe acts** responsible for accidents and also the remedial safety measures required for the same.
- **5. A Bi-partite meeting** between BCCL Management & DGMS officials held on **07.02.2019** under the chairmanship of DDG, Central Zone & in the presence of D(T) P&P which was attended by Area General Managers, Project Officers, Area Safety Officers & officers of Safety Department. In this meeting, safety issues were deliberated for ensuring of both departmental & contractual workers deployed in mines

6. All mines of BCCL have been inspected by Safety inspection team during Annual Mines Safety Week-2019 from 20.01.2020 to 25.01.2020 and during Annual Mines Safety Week-2020 from 14th December to 19th December 2020. Annual Safety Week prize distribution ceremony for the years 2019 & 2020 was held on 21.02.2021.

All mines of BCCL have been inspected by Safety inspection team during Annual Mines Safety Week-2021 from 07.02.2022 to 12.02.2022 and Annual Safety Week prize distribution ceremony for the years 2021 was held on 26.02.2022.

7. Safety Audit of mines of BCCL

- (a) Safety Audit of dumps by internal/inter area audit team: In order to improve the safety standard of dump (OB/Coal) in the mines of BCCL and to take appropriate remedial measures to arrest associated danger from OB dumps specially comprehensive audit of all dumps (old& active) of all mines of BCCL has been done from 09.01.2017 to 19.01.2017 by inter area dump audit team (Safety drive for Dumps).
- (b) Safety audit of mines by external/intercompany teams: Safety audit of 14 UG mines 22 open cast mines and 7 mixed mines has been completed and report submitted by the inter subsidiary team.
- (c) Safety Audit 2020-21 for the mines of BCCL has been completed by Inter Area Multi-Disciplinary Team during the period 01.07.2020 to 31.08.2020.
- (d) Safety Audit 2021-22 for the mines of BCCL has been completed by Inter Area Multi-Disciplinary Team during the period 02.07.2021 to 15.07.2021(1st Phase) 10.08.2021 to 25.08.2021(2nd Phase),10.09.21 to 30.09.2021(3rd Phase).
- (e) Safety Audit 2022-23 for the mines of BCCL has been completed by Inter Area Multi-Disciplinary Team during the period 02.05.2022to 20.05.2022(1st Phase), 06.06.22 to 26.06.2022(2nd Phase), 18.07.22 to 08.08.22(3rd Phase).
