Terms of Reference

1. Background:

Bhart Coking Coal Limited (BCCL), a Subsidiary of Coal India Limited (CIL), plan to engage an agency to provide technical assistance and manage the implementation of a cluster value-chain-based economic livelihood program in Belgaria Township, BCCL, located in Dhanbad district, Jharkhand. Jharia, a critical coal-producing region, plays a vital role in India's energy sector. Jharia Coalfield, with the largest coal reserves in India, is a significant contributor to the local economy of Dhanbad.

However, the Jharia coal belt has been plagued by underground fires for nearly a century. The region also suffers from extensive subsidence and severe environmental issues, including water and air pollution, which have profoundly affected nearby communities, including the city of Jharia. In response to these challenges, Bharat Coking Coal Limited (BCCL) has developed a Jharia Master Planto address the harmful effects of subsidence within its leasehold area. It envisions the rehabilitation of 81 sites in phase -1. This involves rehabilitation of 12523 Non-Legal Title holders families and 1854 Legal title holders families in phase -1. Out of which 2855 Non-Legal title holder families have shifted in Belgaria (a rehabilitation township)

The Project Affected Families (PAFs) residing in subsidence-prone areas are primarily coal miners or workers engaged in related activities, including coal selling, street vending, and domestic work in officers' colonies. The relocation of these families to the township aims to ensure their safety and improve their living conditions. Till now, BCCL has done a need assessment survey at Belgaria tjrough NSDC, report of which is attached for refernce

Families from the project affected areas are being shifted to a safer location in a planned township located in Belgaria, Baliapur, Dhanbad. BCCL seeks to offer these families sustainable livelihood opportunities through this economic development program under the corporate social responsibility. Empowering the disadvantaged and vulnerable individuals is a crucial step towards poverty eradication. This project aims to provide support in the following areas:

- **Entrepreneurial and Economic Self-Employment**: Facilitating the establishment of market-driven microenterprises and self-employment opportunities, both within and around the project area, aligned with current market demands and opportunities.
- **Partnerships and Convergence Support**: Building strategic partnerships and ensuring alignment with relevant development schemes and services.
- Institution Building and Capacity Development: Strengthening institutions (micro-enterprises) and building capacities for long-term, sustainable interventions

2. Eligibility Criteria

Criteria: 1

The bidder should be registered under relevant laws in India and must be eligible to receive CSR funds as per CSR Rules under the Companies Act 2013.

3. Key Objectives

To ensure the safety of displaced individuals and enhance their living conditions through improved livelihood options, the economic livelihood development program has been designed with the following strengthened key objectives:

I. Enhanced Livelihood through Microenterprises:

o **Objective:** To foster sustainable economic development of the target beneficiaries by establishing microenterprise tailored to the specific demand and potential of the local market.

o Strategies:

- Develop and support microenterprises that leverage local resources, align with local supply chains, and meet market demands through innovative product design and market-driven strategies, ensuring they are well-positioned to address existing challenges and capitalise on entrepreneurial opportunities.
- Implement comprehensive support systems for microenterprise development, including business planning assistance, operational guidance, product design and development, skill upgradation, as well as ensuring strong market linkages for sustained growth.
- Facilitate access to necessary infrastructure, to support the establishment and growth of microenterprises.

II. Strategic Convergence and Partnerships:

- o **Objective:** To maximise the effectiveness of the programme through strategic collaboration and synergy among various stakeholders.
- Strategies:
 - Facilitate coordination among development partners, state administration, government bodies, and other relevant organizations to ensure comprehensive support and resource utilization.
 - Establish and nurture collaborative relationships with Business Development Service (BDS)
 providers to deliver essential services such as credit, market access, and technology
 support.
 - Promote cross-sectoral convergence to align program activities with broader development goals and leverage existing resources and expertise.

These strengthened objectives aim to create a robust and sustainable framework for economic development, ensuring that displaced individuals not only achieve better living conditions but also gain meaningful and lasting economic opportunities.

4. Key Challenge

BCCL is willing to provide sustainable livelihood opportunity to the community relocated in Belgariya township from the subsidence locations. This program is designed to cater to the solution and enhancing livelihood opportunities.

Relocated families have experienced disruptions to their coal-dependent livelihoods and have encountered restricted economic opportunities in their new locations. In response to these challenges, the project is set to implement a comprehensive livelihood development program. This initiative will concentrate on providing technical assistance and project implementation to create sustainable livelihood opportunities linked to microenterprise/ group enterprises. The program aims to offer meaningful economic alternatives for men, women, and youth affected by the displacement.

A critical component of this initiative is the formulation of a comprehensive livelihood development strategy. This strategy not only supports the resettled families but also incentivizes additional families to relocate from the project affected areas. By providing viable and attractive livelihood opportunities, the program aims to facilitate settlement in safer environments and promote long-term economic stability and resilience for the communities.

5. Scope of Work:

A. Objective of the Assignment:

The primary objective of this assignment is to drive economic development for beneficiaries residing in Belgaria Township in Dhanbad, Jharkhand. The programme aims to enhance livelihood opportunities, and foster community and enterprise development through a structured approach.

Components:

1. Rapid Assessment:

 Objective: To understand the current status and needs of beneficiaries in terms of livelihood, financial inclusion, and skill development.

o Activities:

- Value chain: Livelihood opportunity to be assessed across four key sectors: Food Processing, Garment Stitching, Waste to Livelihood, and Green Livelihoods. Following a Rapid Assessment/ diagnostic analysis, the 2 most impactful value chains for intervention will be prioritized.
- Baseline Survey: A baseline survey of identified beneficiaries and their mapping regarding income profile, existing activity (if any) and preferences for income-generating activities.
- Value Chain Diagnostics: Identification of potential value-chains and activities for the promotion of self-employment/ Micro-enterprises options for targeted beneficiaries and undertake value-chain diagnostics including market assessment and SWOT analysis.
- Skill Mapping: A comprehensive skill development needs assessment of all targeted beneficiaries and gap analysis w.r.t. technical skills, techno-managerial and soft skills required for specific income generation activities.
- Business Plans for Enterprises: Detailed Business Plans/Detailed Project Reports for necessary microenterprises/ group enterprises need also be prepared.

2. Community and Enterprise Development:

o **Objective:** To create and support community-owned enterprises and infrastructure that promote skill development and microenterprise growth.

o Activities:

- Establish cluster value-chain enterprises and livelihood hub to provide necessary services and infrastructure.
- Develop and implement training programs focused on entrepreneurship for various beneficiary groups for optimal utilization for microenterprises
- Provide support for the setup of microenterprises, including assistance with business planning, market access, and operational management.
- Facilitate infrastructure development, such as workspace, equipment, and technology, to support enterprise activities.
- Implement marketing strategies and help beneficiaries access social benefits and other critical services

3. Partnerships and Convergence:

o **Objective:** To leverage external resources and ensure holistic support through strategic partnerships and scheme convergence.

o Activities:

- Identify and engage with Business Development Service (BDS) providers for support in areas such as credit, market access, and technology.
- Establish partnerships with relevant stakeholders including government agencies, NGOs, and private sector organisations.
- Facilitate convergence with existing government schemes and programmes to align with broader development goals and enhance resource utilisation.
- Develop a network of support services to ensure comprehensive assistance for beneficiaries.
- Sustainability of enterprise at the end of the project
