- The candidates are requested to bring **RT-PCR test report - Negative (not RAT Test)**. The RT-PCR test report should be within 72 hours of scheduled date of the medical board.
- Details of Ex-Employee - **1. Date of Death 2. Date of Separation 3. Date of Last Duty.**
- The requisite documents for IME should be reached in the office of undersigned (01) one week i.e.(02.08.2022) prior the date of IME.**


