6. The candidates are requested to bring **RT-PCR test report - Negative (not RAT Test)**. The RT-PCR test report should be within 72 hours of scheduled date of the medical board.

8. **The requisite documents for IME should be reached in the office of undersigned (01) one week i.e.(27.08.2022) prior the date of IME.**
