Proposal for modalities to be adopted for allotment of Quarter to employees after submission of application through Online Mode, 10A.

SoP as placed before FDs was deliberated and agreed by FDs and for this purpose, it was advised that procedure should be transparent and easy to follow and with advice that in case of allotment of quarter to an employee who is posted in Area, approval of GM of the concerned area must be obtained and it must be incorporated in the system itself in case of transfer from one Area to another Area or from Area to HQ and vice versa.



- Uploading of vacant list of type wise quarter by 5th of every month in the BCCL Quarter Application System by the concerned Nodal Officer of Area/HQ viewable to all employees in the format as follows:

Allotment Norms-As per BCCL House Allotment rule:

- Quarters under the administrative control of Koyla Nagar
 Township Administration in Koyla Nagar, Karmik Nagar &
 Ex-Coal Board Colony shall only be allotted to employees
 (Executive/Non-Executive) who are at the payroll of HQ/at
 the time of allotment.

Allotment of Quarter will be done/Order issued & communication for end of process.

Explanation	Basic Point	One (1) Point for every ₹ 100/- of Basic Pay i.e., First Four (4) Digit of Basic Pay where Basic Pay is more than ₹ 1,00,000/- per month and First (3) Three Digit in all other cases. In case where the Basic Pay is not in multiple of hundred, the pay of more than ₹ 50/- will be given one point.	
:	HQ Point	One (1) Point for each Year, since joining date at HQ. (If 06 Months cross in each year, then 01 point will be added)	
	Grade Point	One (1) Point for each Year, since coming in the present grade. (If 06 Months cross in each year then 01 point will be added)	

Principle of Allotment: When two or more employee have equal points, the house allotment committee will take decision

based on the following: i) Inter-se Seniority

ii) Nature of Job

iii) Place of Posting

Change of Residence:

- No change of residence will be permissible within one year of the allotment of an accommodation except in case of tion.
- Once a quarter is allotted to an employee consequent upon receipt of application through online mode and if the concerned does not take possession of the said quarter, the employee will be able to re-apply only after a period of six (6) months.
- Vacant next higher grade quarters (one grade up only) upto B type may be allotted to non-entitled employees temporarily for one year subject to periodical review if the quarter remains vacant even after allotment and no specific application is pending against the said quarter by the entitled employees.
- Deduction of licence fee & Electricity charges will be applicable from the date of actual occupancy of quarter.
- Other norms as specified in the House Allotment Rule shall strictly be followed for uniformity and transparency.
