**NOTICE FOR FILING OF RAIL PROGRAMS BY NON-REGULATED SECTOR (NRS) FSA
CONSUMERS (RAIL MODE) FOR JANUARY 2026**

1. NRS (Non-Regulated Sector) consumers having valid FSAs with BCCL under rail mode as per the list attached (based on the applicable quota for the month of Jan.'26) are hereby notified to submit online Rail programme through FOIS for the month of Jan.'26. Consumers are requested to file Rail program preferably till **20-01-2026** and to select FSAN category while filing Annexure-C in FOIS.
2. Further, consumers are required to submit the relevant documents as indicated in the notice No. BCCL/M&S/622 dtd. 19.06.2025 (copy attached) preferably by **22-01-2026** for further processing of Rail programs by BCCL.
3. In case of the consumers filing program, Proforma Invoice (PI) shall be raised by BCCL for the rakes as per MSQ of above-mentioned month or as agreed with mutual consent. Against such PI, the consumers shall be required to make payment through Banking Interface within the date indicated in the PI (tentatively by **27-01-2026**). Consumers are requested to check the registered e mail id/ banking portal for details regarding receipt of PI.
4. After deposition of payment against PI, payment details may be shared through e-mail to **railoperation.bccl@coalindia.in**.
5. It may be noted that non-submission of Rail program, required documents & non-payment shall be considered as Deemed Delivery as per FSA.
6. For taking allotments as per CIL guidelines for desirous consumers in cases where pending value paid arrear allotments is/ are more than one-month MSQ, notarized affidavit along with undertaking may be submitted by consumer for maintaining the advance payment equivalent to one-month MSQ at any given point of time and that the payment for the unpaid arrear allotted rake would be deposited before actual loading, if such facility is availed. Consumers opting for One MSQ Scheme are also requested to deposit coal value before movement of rake to maintain the advance payment equivalent to one-month MSQ at any given point of time (over & above the financial coverage).
7. The consumers availing LC facility are requested to maintain a valid LC equivalent as per CIL/BCCL guideline. Considering the bill value in recent days, LC is to be submitted for a **minimum amount of Rs. 2.25 crores for 1 rake** to avoid any delay of processing of payment.

All Consumers having FSA under NRS Linkage Auction (under Rail/Road mode) are required to submit the following documents as per **annexure-II of the FSA & State Govt.** rules for issuance of sale orders and lifting of coal as per monthly schedule quantity (MSQ):


1. Notarized power of attorney. (as submitted at the time of execution of FSA)
2. Proof of Payment of coal value as per FSA.
3. Authorization document from purchaser for lifting/supervise loading (**Format enclosed**).
4. Copy of dealer registration of JIMMS portal (compulsory in Jharkhand).

As mentioned in the **annexure-II of the FSA**, validity of the documents like CTO/Factory License wherever applicable is to be maintained for lifting of coal. Coal supply may continue for a maximum of three months after the date of expiry of the CTO/Factory License if the Bidder has submitted proof of its application for renewal of the same. Non-compliance of the same shall be sole responsibility of the purchasers and shall attract action as per the FSA.

The above set of original documents (with one set of photo copy) are to be submitted by the consumers on or before 07th Date of every month in the Rail / Road Operation Section(s) of M&S department. The submitted documents shall be forwarded to Linkage Auction Section of M&S for verification and records and for monthly Deemed Delivered Quantity (DDQ) calculation as per clause no: 5.93 of the FSA. Thereafter, the colliery wise authorization letters submitted by the consumers shall be forwarded to concerned Area Sales Manager by the Rail / Road Operation Section(s) for allowing lifting of coal to the authorized person(s) only.

Non submission of above mentioned documents as per FSA will be considered as consumer's unwillingness to lift the Monthly Schedule Quantity and shall be considered as failure on the part of the Purchaser and accordingly will be part of Deemed Delivered Quantity.
