#### Terms and Conditions:

- 1. The admissibility of application of a candidate shall be subject to the following conditions:
  - a) Only permanent employees who have fulfilled the minimum prescribed qualification as mentioned against the post, as on 30.09.2024 may apply.
  - b) Employees belonging to the following undermentioned posts will not be eligible to apply for the above mentioned posts:
    - Employees appointed on the basis of ITI certificate, Diploma Certificate and other Technical Certificates in the Company.
    - Employees under essential categories viz. Dozer Operators, Dumper Operators, Shovel Operators, Pay Loader Operators, Grader Operators, Driller Operators, Dragline Operators and other HEMM Operators.
    - Electrical Supervisors, Electricians, EP Electricians of E&M and Excavation cadre.
    - iv) Mining Supervisory Personnel, Survey personnel and other statutory
    - v) Medical and paramedical staffs viz. Staff Nurse, Lab. Technician, X-ray Technician, Pharmacist, ECG Technician, Tech Audiometry, Tech. Refraction/Optometry, Tech. Dental, Tech. Dietician, Physiotherapist, and Dresser etc.
    - vi) Employees already in ministerial cadre, accounts cadre, civil engineering & driver.
    - vii) Security Personnel including trainees deployed in Security.
    - viii) Any other shortage category/employees.

c) Trainees are not eligible to apply.

d) Candidate must have minimum "GOOD" CR rating for the completed year of service and in case of candidates who have completed more than 03 years of service, then CR rating for last 03 years will be required.

e) Vigilance / Departmental Clearance of the candidate shall be "Clear".

- 2. The Selection of candidate shall be subject to vacancy as per the Approved Manpower Budget of BCCL in force at the time of final selection.
- 3. Applicants will be called for the trade/selection test on the date and venue decided by NEE Dept., HQ.
- 4. On the basis of marks obtained in the selection test a panel will be prepared:
  - a) In case two or more candidates secure equal marks in the test, the date of appointment will be taken into consideration for determining the seniority of the candidate.
  - b) Even after considering the date of appointment the tie persists, the DOB of the candidate shall be taken into consideration for determining the final seniority and the candidate senior in age will be kept above in the panel.
- 5. Final Merit list will be drawn from the panel as per vacancy position, norms, Cadre Scheme, Vigilance clearance, etc. and the name of eligible candidates will be recommended as per the merit list.
- 6. Reservation quota for SC/ST/PWD candidates shall be considered as per govt. norms/ guidelines.
- 7. Candidate shall note that at any stage of selection or later, if he/she is found indulging in any misconduct, the candidature will be summarily rejected and disciplinary action will be initiated as per the Certified Standing Orders.
- 8. Director (Personnel), BCCL reserves the right to modify/ alter/ restrict/ cancel the selection process, at his discretion without assigning any reasons whatsoever. The decision of Director (Personnel), BCCL shall be final.
- 9. Selected candidates could be posted in any Area/Unit/HQ Establishment of BCCL.
- 10. Candidates are required to bring the Identity card bearing the photograph of the candidate, issued by the company for appearing in the Trade test.
- 11. Any amendment/modification relating to this internal notification will be notified on BCCL website only. Candidates are advised to check the BCCL website regularly.
- 12. In case of any doubt, English Version of Internal Notification will be treated as final and valid.
