Any defect observed on this account shall be attended immediately and replace the materials within 15 days free of cost If the Supplier, having been notified, fails to remedy the defect(s) within fifteen days, the Purchaser may proceed to take such remedial action as may be necessary, at the Supplier's risk and expense and without prejudice to any other rights which the Purchaser may have against the supplier under the Contract.
