# **TERMS & CONDITIONS:**

- 1.PAYMENT TERMS:100% within 21 days of receipt and acceptance of the materials by the consignee or from the date of receipt of Bills, whichever is laterby the consignee.
- 2. PRICES: FIRM and F.O.R. destination basis; Packing & Forwarding charges: Nil; Freight & Insurance charges: Nil.
- 3.GST:- (a) GST shall be paid extra as legally applicable during the scheduled delivery period. Presently applicable GST rate is 18% (IGST).
  - (b) The invoice shall be raised by you giving all the details as per GST Act/ Rules so as to enable BCCL to avail Input Tax Credit.
  - (c) You have to ensure proper uploading in your return so that BCCL may be able to avail Input Tax Credit.
  - (d) You have to ensure that if BCCL does not be able to avail Input Credit due to fault of the supplier then the loss amount to be recovered from the supplier.
  - (e) The benefit of any extra input tax credit earned by you, if any, in future shall be passed on to BCCL.
  - (f) E-way bill, if required, shall be arranged by you.
  - (NB: Any increase in taxes & duties beyond the stipulated delivery period will be to your account).
- 4. **DELIVERY SCHEDULE:**-Delivery to be completed within 30 days or earlier from the date of receipt of supply order. The delivery schedule will be counted from the 10th day of the date of order and the date of receipt of materials at our stores shall be treated as the date of delivery. Any increase in the rate of taxes & duties beyond delivery period will be to your account.
- 5. **SECURITY MONEY:** -You will be required to deposit as security money 10% of the total value of the contract (including Taxes, duties, and other charges to the FOR Destination prices) in the form of Bank Draft / Bank Guarantee within 15 days from the date of order.

In case of Security Deposit in form of BG, the bank guarantee (as per Annexure I) issued by bank on behalf of the supplier in favour of Bharat Coking Coal Limited, shall be in paper form as well as issued under "Structural Financial Messaging System".

The validity of B.G. will be for a period of three months beyond the expiry of delivery period. If you fails to deposit the security deposit within 15(fifteen) days from the date of order, the same shall be recorded as unsatisfactory performance for future dealings apart from taking any other penal action as may be deemed fit by BCCL. The Security Money shall be refunded within 30 days of satisfactory execution of contract. For unsatisfactory execution of contract and/or failure of execution of contract, the security money shall be forfeited.

- 6. INSPECTION Pre-despatch Inspection shall be carried out by CMPDIL, Ranchi at your Works premises. Inspection Fees @1% on FOR destination price and GST @18% or as applicable on inspection charges shall be paid initially by you along with your Inspection Call, which shall be subsequently reimbursed by BCCL along with your supply bills against documentary evidence e.g. money receipt etc. Final inspection shall be carried out at the consignee end after receipt of materials by the concerned technical head or their authorized representative(Annexure-II).
- 7.TRANSIT INSURANCE—Shall be arranged and covered by you for safe arrival of materials to the consignee end at your cost and risk.

# 8. PENALTY FOR FAILURE TO SUPPLY IN TIME

The delivery of stores stipulated in Purchase order shall be deemed to be of the essence of the contract and delivery of the stores must be completed by the date specified. No materials should be supplied beyond the specified delivery period, unless specific approval has been obtained from the purchaser.

P.N

In the event of failure to deliver the stores within the stipulated date/ period in accordance with the samples and/or specification mentioned is the supply order, and in the event of breach of any terms and conditions mentioned in the supply order. Bharat Coking Coal Limited reserves the right:

- a) To recover from successful tenderer, as agreed liquidated damages, a sum not less than 0.5% (half percentage) of the price of the stores which successful tenderer has not been able to supply (for this purpose part of a unit supplied will not be considered) as aforesaid for each week or part of a week during which the delivery of such stores may be in arrears limited to 10%. Where felt necessary the limit of 10% can be increased to 15% at the discretion of Head of the Materials Management Division.
- b) To purchase elsewhere, after due notice to the successful tenderer on the account and at the risk of the defaulting supplier the stores not supplied or others of a similar description without canceling the supply order in respect of consignment not yet due for supply or
- c) To cancel the supply order or a portion thereof, and if so desired to purchase the store at the risk and cost of the defaulting supplier and also
- d) To extend the period of delivery with or without penalty as may be considered fit and proper. The penalty, if imposed shall not be more than the agreed liquidated damages referred to in clause (a) above.
- e) To encash any Bank guarantee which is available for recovery of the penalty or
- f) To forfeit the security deposit full or in part.
- g) Whenever under the contract a sum of money is recoverable from and payable by the supplier, BCCL shall be entitled to recover such sum by appropriating, in part or whole by deducting any sum or which at any time thereafter may be due to the successful tenderer in this or any other contract with Bharat Coking Coal Ltd. or any subsidiary of Coal India Ltd. - ii) If at any time during the said period the supplier offers lower sale price of such stores to any other organization at a price lower than the price chargeable under this contract, the supplier shall forthwith notify such reduction or sale to the consignee concerned under intimation to GM (MM), Bharat Coking Coal Limited, Commercial Block, Level –III, KoylaBhavan, Koyla Nagar, Dhanbad and the price payable under the contract for the stores supplied after the date of coming into force of such reduction or sale, shall stand correspondingly reduced. The above stipulation will not, however apply to exports by the supplier.
  - 10.SUBMISSION OF BILLS-100% value of bill duly stamped, signed & pre-receipted in six copies, as per terms of the order should be submitted for payment to the paying authority through consignee. Any defects observed on this account shall be attended within 07 days from the date of receipt of report and immediately replace the material within 30 days free of cost.

If the materials are sold at any lower rate than that mentioned in this contract to any other agency, the same will automatically be applied to this contract from that date"

13.PACKING - Consignment shall be supplied in suitable standard proper packing as per NIT.

#### 14.FORCE MAJEURE CLAUSES -

If the execution of the Contract / Supply Order is delayed beyond the period stipulated in the Contract / Supply Order as a result of hostilities, declaration of embargo or blockade or flood, acts of nature or any other contingency beyond the supplier's control due to act of God, then BCCL may allow such additional time by extending the delivery period as is considered justified by the circumstances of the case and its decision shall be final. In case additional time is granted by BCCL for execution of the Contract/ Supply Order, the Contract/Supply Order shall be read and understood as if it had contained from its inception the delivery date as extended.

- a) The successful bidder will advise, in the event of his having to resort to this clause, by a registered letter, duly certified by the local chamber of commerce, or statutory authorities, the beginning and end of the causes of the delay, within 15 days of the occurrence and cession of such force majeure conditions. In the event of delay lasting out of force majeure, BCCL will reserve the right to cancel the contract, and provisions governing termination of contract as stated in the bid documents will apply.
- b) For delay arising out of Force majeure, the bidder will not claim the extension in completion date for a period exceeding the period of delay attributable to the causes of force majeure and neither BCCL nor the bidder shall be liable to pay extra cost provided it is mutually established that the force majeure conditions did actually exist.

# TECHNICAL REQUIREMENT AND SPECIFICATIONS

- 1. Safety Helmet should be strictly as per DGMS Circúlar (Approval) No-3 Dhanbad, Dated 14/08/2014.
- 2. Each helmet should permanently mark with manufacturer's name/model, year & month of manufacturing. The Helmet shall also bear marking of BIS license with relevant IS number.
- 3. The manufacturer shall submit declaration stating that it is "suitable for use in mines."
- 4. Bidder must submit copy of valid BIS license, Test Report of Safety Helmets from any Govt. or Govt. approved laboratory duly attested by Notary Public for the Helmets at the time of supply of material.
- 5. Safety Helmet conform to the standards as specified in IS: 2925-1984 (with amendments done in the year 1988, 1999, 2000, 2002) with latest amendment of the Bureau of Indian Standard.
- 6. BCCL Monogram to be screen printed on front of the Helmet
- 7. Helmet shall be fitted with adjustable head band, adjustable cotton chin strap, lacing cord along with lamp bracket and cable grip.
- 8. The head band size shall be 540mm to 590mm.
- 9. Harness/Headband etc. should be sweat resistance, non-irritant and should not cause any skin diseases.
- 10. In-bye end rivets of cap lamp holder attached to the Helmet should not be projected.
- 11. The Helmet should have eight nos. of ventilation holes
- 12. The supplied Helmets shall be accepted after satisfactory test report from Govt. or Govt. approved Test House of the samples collected by joint sampling in presence of the authorized representative of the suppler. The cost of testing of the samples taken by joint sampling shall be borne by the supplier.
- 13. Guarantee/Warranty- Material supplied should be guaranteed for a period of 12 months from the date of issue of the Helmet to the users or 18 months from the date of receipt and acceptance of the material at consignee end whichever is earlier.
