- 1.1 This contract is governed by the General Terms and Conditions, conditions stipulated to this Product/Service as provided in the Marketplace.
- 1.2 This Contract between the Seller and the Buyer, is for the supply of the Goods and/ or Services, detailed in the schedule above, in accordance with the General Terms and Conditions (GTC) unless otherwise superseded by Goods / Services specific Special Terms and Conditions (STC) and/ or BID/Reverse Auction Additional Terms and Conditions (ATC), as applicable
- 2. Buyer Added Bid Specific Terms and Conditions-
- 2.1 Scope of Supply:

Scope of supply (Bid price to include all cost components): Supply Installation Testing and Commissioning of Goods

2.2 Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- a. Copy of PAN Card.
- b. Copy of GSTIN.
- c. Copy of Cancelled Cheque.
- d. Copy of EFT Mandate duly certified by Bank.
- 2.3 Generic

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

### 2.4 Generic

Upload Manufacturer authorization: Wherever Authorised Distributors are submitting the bid, Manufacturers Authorisation Form (MAF)/Certificate with OEM details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid.

### 2.5 Warranty.

Timely Servicing / rectification of defects during warranty period: After having been notified of the defects / service requirement during warranty period, Seller has to complete the required Service / Rectification within 7 days time limit. If the Seller fails to complete service / rectification with defined time limit, a penalty of 0.5% of Unit Price of the product shall be charged as penalty for each week of delay from the seller. Seller can deposit the penalty with the Buyer directly else the Buyer shall have a right to recover all such penalty amount from the Performance Security (PBG).Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Buyer shall have the right to get the service / rectification done from alternate sources at the risk and cost of the Seller besides forfeiture of PBG. Seller shall be liable to re-imberse the cost of such service / rectification to the Buyer.

#### 2.6 Certificates.

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

#### 2.7 Buver Added Bid Specific ATC:

Proven-ness criteria: - a. The equipment offered by the tenderer shall be considered proven provided the quoted model must have been supplied by the bidder in India to mining industry and/or to the other Industries (Private or Government/ Public Sector Undertaking) and performed satisfactorily for a minimum period of one year from the date of comm issioning (window period). The performance of only those equipment would be considered for assessing provenness which have been commissioned 1 year prior to the date of o pening of tender but not prior to 5 years from the date of opening of tender. b. In case the quoted model has not been supplied by the bidder in India or if supplied and commissi oned in India but the same has not completed required years of performance for provenness as mentioned above, the offered equipment will be considered proven if offered eq uipment, which have been commissioned worldwide 1 year prior to the date of opening of tender but not prior to 5 years from the date of opening of tender have performed sati sfactorily for a minimum period of 1 year from the date of commissioning. In case the indigenous manufacturer is quoting the same type & model of the equipment as supplied by their foreign collaborator worldwide in the p ast and the quoted model of indigenous manufacturer has either not been supplied in India or if supplied and commissioned in India, but the same has not completed the requir ed years of performance for provenness as mentioned above, the quoted model will be considered proven if offered equipment which have been commissioned 1 year prior to th e date of opening of tender but not prior to 5 years from the date of opening of tender have performed satisfactorily for a minimum period of 1 year from the date of commissio ning worldwide. The worldwide population, foreign collaborator's experience of supplying the offered worldwide will be considered for provenness only when the Indigenous ma nufacturer submits notarised copy of their collaboration agreement with the foreign collaborator which should be valid as on date of opening of tender and should remain valid at least upto supply and commissioning of the last equipment covered in the contract. However, the principle manufacturer will confirm to ensure supply of spares, consumable a nd service support for smooth running of the equipment throughout its life from the date of commissioning must be enclosed with the offerd. "Satisfactory Performance" means the supplied equipment must have achieved the guaranteed annual availability, if any, as per the performance guarantee clause of the supply orders/contracts for a minimum pe riod of one year from the date of commissioning.

#### 2.8 Purchase Preference (Centre):

Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry.
