Scope of Supply:

Diamond Section Drill Rods 1-9/16" dia solid plain shank with slotted Bit, suitable for accommodating 1-11/16" dia Drill Bits for Drilling in coal. The drill Rod will be manufactured from EN-9 Steel conforming to IS7868 (latest). The Drill Rod should be so heat treated as to obtain the following hardness figures: -

Hardness at the core surface:200HV+/- 10 counts Hardness at the fine surface:240HV=+/- 10 counts

The difference in hardness at core surface and fine surface will not exceed 50HV with tolerance as per IS:7868(latest), Length of Rod-6 ft. (1.82 Mtr.)
