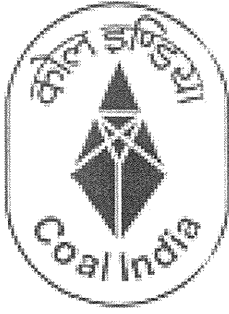

**TAX: JVAT** Payable extra @ 14 %.( Input Tax credit as admissible shall be availed by BCCL).

**Warranty/Guarantee:** The firm shall be fully responsible for manufacturer's warranty in respect of proper design, material, quality, workmanship and correctness of the parts and items shall have guarantee/ warranty of 12 months from the date of fitment on the equipment or 18 months from the date of supply whichever is earlier. In case of failure the defective parts will be replaced free of cost within 30 days of intimation.

BCCL will avail CENVAT credit on admissible inputs and capital goods. You should submit pre-receipted and stamped Excise cum Tax Invoice showing the amount of CVD & SAD as per strength of Bill of Entry. The excise cum Tax Invoice must contain all the following information as required under rule 11 of Central Excise Rule 2002:-

- a) Registration no. of the supplier.
- b) Address of the concerned Central Excise Division.
- c) Name of the consignee.
- d) Description of goods supplied.
- e) Tariff heading and sub headings.
- f) Time and date of removal.
- g) Mode of Transport.
- h) Vehicle Registration number.
- i) Rate of duty.
- j) Quantity and Value of goods, and duty payable thereon.

(B) Following documents duly authenticated by you wherever applicable, should be submitted to the paying Authority:-

- (I) 100% bill in triplicate duly pre-receipted and stamped.
- (II) Copy of consignment note and copy of the warranty certificate.
- (III) Price certificate.
- (IV) Any other document, if required as per the rate contract.

**Consignee:** Depot officer, Regional Stores, Barora Area, BCCL, Dhanbad.

**Paying Authority:** CM (F) MM/HOD, Pur-Fin, BCCL, Dhanbad.

**Price Certificate:** Please certify on the body of each & every bill that the prices charged in this invoice does not exceed the lowest price at which we sell or offer to sell the stores of identical description to any other organisation during the period of contact.

**Price Fall Clause:** It will be condition of the order that all through the currency of the prices at which you shall supply stores ,shall not exceed the lowest price charged by you to any other agency including DGS&D. IN the event of price going down , you shall promptly pass on such information to enable this Company to amend the ordered rate.

- i) If at any time , during the said period , the contractor reduces the sale price of such stores or sells such stores to any other organization at a price lower than the price chargeable under this contract , the contractor shall forthwith notify such reduction of sale price to the consignee concerned under intimation to the Chief General Manager(MM), BCCL, Dhanbad & the price payable under the contract for the stores supplied after the date coming into force of such reduction or sale shall stand correspondingly reduced.
- ii) The contractor shall furnish to the Consignee/Paying Authority concerned, with a copy to the Chief General Manager (MM), BCCL HQ, Dhanbad, a certificate in the following along with each bill.

"I/We certify that the stores of description identical to the stores supplied to the consignee concerned under the contract therein have not been sold by me/us to any other organization at the commencement of the contract up to the period of completion of delivery at a price lower than the price charged to the concerned consignee of the Contract."

Failure in the submission of aforesaid by the contract holder may result in with -holding of the payment of their bills against such supply.

**Warranty Replacement:** In event of any warranty failure, the firm shall visit site for joint inspection & replace the defective material free of cost within 30 days of receipt of intimation from the user.

**Mode of Despatch:** By Road transport only on door delivery basis at your risk.

**Security Deposit:** Exempted as per CCL RC

**Liquidated Damage clause:** In the event of failure to delivery or dispatch the stores within the stipulated date/ period in accordance with the samples and/or specification mentioned is the supply
