4.SALES TAX:JVAT shall be payable extra, as legally applicable at the time of delivery within the stipulated delivery period. The offered applicable rate of JVAT is @4%.

5.DELIVERY PERIOD: to complete the supply within NINE months, which shall be reckoned from the 10th day from the date of issue of the order. However, you may improve upon the delivery.

6.PAYMENT TERMS: 80% payment towards supply of equipment with accessories alongwith 100% taxes & duties against submission of Performance Bank Guaranty shall be payable within 21 days of receipt and acceptance of materials at site or the date of submission of the bill, whichever is later. Balance 20% payment shall be made within 30days after successful completion of erection, testing and commissioning and final acceptance of the equipment. The site for installation shall be made readily available by GM(E&M), BCCL on receipt and acceptance of the materials at consignee's end. For payment you shall submit pre-receipted invoice in quadriplicate along with Installation and commissioning note in original duly certified by the user to the paying authority.

9.GURANTEE /WARRANTY: The supply shall be covered by the maker's standard guarantee as follows:

The supplier shall warrant that the equipment supplied under the contract / supply order (a)is new, unused and of current design not likely to be discontinued or become obsolete till the life of the offered equipment.

(b) Is in accordance with the contract specifications.

(c) Shall have no defects arising out of design, materials or workmanship.

The supplier shall guarantee for the satisfactory performance of the complete equipment/ stores for a period of 12 months from the date of commissioning or 18 months from the date of dispatch, whichever is earlier. In the event of any defects in materials, design and workmanship during the aforesaid period is found due to faulty design or poor workmanship, the defective part or parts will be replaced by the supplier at site free of cost within 30 days of settlement of warranty claims. The supplier will be required to stock spare parts to take care of warranty failures. Spares should be available within 2 weeks of the breakdown being intimated to them.

The guarantee/composite warranty shall be submitted along with the bill. The warranty shall cover for the total equipment so that the necessity of having to approach different manufacturers of various components/assemblies does not arise and all services under warranty clause shall be the responsibility of the ultimate supplier of the composite equipment. You will also replace the defective parts, if any, during the warranty period free of cost. The responsibility to collect the defective / rejected material will lie with the supplier and the cost for such collection will have to be borne by the supplier.

10.SECURITY DEPOSIT: You shall deposit as security money 10% of the value of the contract ie for Rs 3,49,317.00 (Rupees Three Lakhs forty nine Thousand Three hundred and seventeen only) in the form of Bank Draft /Bank Guarantee within 15 days from the date of order. The validity of B.G. will be for a period of three months beyond the expiry of delivery period. 12.Inspection and Tests:

i)The purchaser or its authorised representative shall have the right to inspect and/or to test the goods to confirm their conformity to the contract. The purchaser shall notify the supplier in writing of the identity of any representative retained for these purposes.

ii) The inspections and tests may be conducted on the premises of the supplier or its sub-contractors), at point of delivery and/or at the goods final destination when conducted on the premises of the supplier or its subcontractor(s), all reasonable facilities and assistance, including access to drawings and production date, shall be furnished to the inspectors at no charge to the purchaser.

iii) Should any inspected or tested Goods fail to conform to the specifications, the purchaser may reject them and the supplier shall either replace the rejected goods or make all alternatives

necessary to meet specification requirements free of cost to the Purchaser.

iv) The Purchaser's right to inspect, test and, where necessary, reject the goods after the Goods arrival in the Purchaser's country shall in no way be limited or waived by reason of the Goods having previously been inspected, tested and passed by the Purchaser or its representatives prior to the Goods shipment from the country of origin.

v)Materials are subject to inspection by the purchaser before dispatch. The materials may also be subject to stage inspection by a third party nominated by BCCL for the purpose. Final inspection shall,

however, be carried out at the consignee's end.

vi)Nothing in these documents shall in any way release the supplier from any warranty or other

obligations under this contract.

vii)The purchaser shall, at its discretion, have the right to test the ordered material in a Government Test House or in a test house nominated by the purchaser. In case of failure of the material after testing, the cost of tests as well as of the material shall have to be borne by the supplier.

Final Inspection at destination site shall be arranged by the consignee within one week from the date of receipt of the material. Supplier's technical representative must be available at the time of inspection.

13.TRANSIT INSURANCE: Shall be arranged and covered by you for safe arrival of the materials to the consignee end at your cost and risk.

14.PENALTY FOR FAILURE TO SUPPLY IN TIME: Liquidated Damage(LD) Clause/Risk Purchase clause: The delivery of stores stipulated in Purchase order shall be deemed to be of the essence of the contract and delivery of the stores must be completed by the date specified. No materials should be supplied beyond the specified delivery period, unless specific approval has been obtained from the purchaser.

In the event of failure to deliver the stores within the stipulated date/ period in accordance with the samples and/or specification mentioned is the supply order, and in the event of breach of any terms and conditions mentioned in the supply order. Bharat Coking Coal Limited reserves the right:

a) To recover from successful tenderer, as agreed liquidated damages, a sum not less than 0.5% (half percentage) of the price of the stores which successful tenderer has not been able to supply (for this purpose part of a unit supplied will not be considered) as aforesaid for each week or part of a week during which the delivery of such stores may be in arrears limited to 10%. Where felt necessary the limit of 10% can be increased to 15% at the discretion of Head of the Materials Management Division .

b) To purchase elsewhere, after due notice to the successful tenderer on the account and at the risk of the defaulting supplier the stores not supplied or others of a similar description without cancelling the supply order in respect of consignment not yet due for supply or

c) To cancel the supply order or a portion thereof, and if so desired to purchase the store at the risk and cost of the defaulting supplier and also

- d) To extend the period of delivery with or without penalty as may be considered fit and proper. The penalty, if imposed shall not be more than the agreed liquidated damages referred to in clause (a)
- e) To encash any Bank guarantee which is available for recovery of the penalty or
- f) To forfeit the security deposit full or in part.
- g) Whenever under the contract a sum of money is recoverable from and payable by the supplier, BCCL shall be entitled to recover such sum by appropriating, in part or whole by deducting any sum or which at any time thereafter may be due to the successful tenderer in this or any other contract with Bharat Coking Coal Ltd. or any subsidiary of Coal India Ltd. 15.PRICE FALL CLAUSE:

ii) If at any time during the said period the supplier offers lower sale price of such stores to any other organization at a price lower than the price chargeable under this contract, the supplier shall forthwith notify such reduction or sale to the consignee concerned under intimation to CGM(MM), Bharat Coking Coal Limited, Commercial Block, Level-III, Koyla Bhawan, Koyla Nagar, Dhanbad and the price payable under the contract for the stores supplied after the date of coming into force of such reduction or sale, shall stand correspondingly reduced. The above stipulated will not, however apply to exports by the supplier.

ACOUSTIC ENCLOSURE

The Engine Alternator Set would be placed inside an Acoustic Enclosure. The acoustic enclosure shall be fabricated from 14/16 Gauge CRCA sheet and the design is certified by ARAI, Pune, an accredited body of CPCB and Type Certificate concerning noise pollution shall be provided.

The sound level at 1 meter distance from the enclosure surface ,under free field condition would be less than 75 db.

The fuel tank and the Control Panel may be placed outside the canopy.

Attenuators are placed in the hot air outlet and cooling air inlet.Residential type Exhaust Silencer is mounted on the enclosure.All joints are sealed with fireproof Neoprene gaskets,to withstand high temperature and pressures.All high temperature exposed surfaces are insulated by glass wool with Aluminium cladding.The enclosure is painted with weatherproof,acidproof, heat-resistant Powder coating after pretreatment for degreasing,de-rusting,pickling,phosphating and passivity for durability inside the Canopy.

Emergency Push button shall also be provided on the outside of the enclosure for exigency. The insulating material used shall conform to IS/CPCB Specification.

Base Frame

The Diesel Engine and the Alternator will be mounted on a suitable base frame of sturdy design made of Steel channel all welded and stress relieved.
