Dear Sirs,

Since, GST has been implemented by the Government of India & it is w.e.f 01.07.2017 as such our rate contract no. BCCL/PUR/KOL/72/MS (B&N)/RC/2015/472 dtd 15.12.15 concluded with you for supply of M S Bolts & Nuts of different sizes is hereby amended in place of existing entries as followings:

1. Basic rates of the all the items covered in RC will be same as given in above referred Rate Contract.

2. Following clauses are also added in the above Rate Contract:

- (a) GST: GST shall be paid extra as legally applicable during the scheduled delivery Period. Present rate is 18% [IGST @18%].
- (b) The invoice shall be raised by you giving all the details as per GST Act/ Rules so as to enable BCCL to avail Input Tax Credit.
- (c) You have to ensure proper uploading in your return so that BCCL may be able to avail Input Tax Credit.
- (d) You have to ensure that if BCCL does not be able to avail Input Credit due to fault of your side then the loss amount to be recovered from you.
- (e) The benefit of any extra input tax credit earned by you, if any, in future shall be passed on to BCCL.
- (f) E-Way bill, if required, shall be arranged by you.
- (g) Clauses related to Excise Duty and Central Sales Tax of the above mentioned Rate Contract stands deleted.
