5. **FREIGHT & INSURANCE: NIL**, to be covered by the supplier.

6. **PAYMENT TERM:** 100 % payment within 21 days from the date of receipt and acceptance of materials or date of submission of bill whichever is later at the consignee end. Payment will be made through electronic fund transfer (EFT) and Electronic clearance system (ECS).

7. **DELIVERY PERIOD:** 50% within 45 days of receipt of Purchase Order & Next 50 % within 90 days of receipt of Purchase Order.

The delivery schedule will be counted from the 10th day of the date of order and the date of receipt of materials at our stores shall be treated as the date of delivery. Normally extension of delivery period will not be granted. However, in case extension of delivery period becomes essential, the supplier will send their request for extension of delivery period to the purchaser before expiry of delivery period. In the event of failure to supply the ordered material within the stipulated delivery schedule, the successful tenderers must obtain extension of delivery period, with or without liquidated damage, before dispatch/supply of the ordered goods. Supplies made without obtaining extension of delivery period shall be liable for non-acceptance at the stores.

8. **GUARANTEE/ WARRANTY:** The supply shall be covered by the maker's standard guarantee as follows:

The supplier shall warrant that the equipment supplied under the contract / supply order

(a) is new, unused and of current design not likely to be discontinued or become obsolete till the life of the offered equipment.

(b) is in accordance with the contract specifications.

(c) shall have no defects arising out of design, materials or workmanship.

The supplier shall guarantee for the satisfactory performance of the supplied item for a period of 12 months from the date of installation and commissioning or 18 months from the date of receipt and acceptance, whichever is earlier. In the event of any defects in materials, design and workmanship during the aforesaid period is found due to faulty design or poor workmanship, the defective part or parts shall be attended immediately and same will be replaced by the supplier at site free of cost within 30 days of settlement of warranty claims.

The guarantee/composite warranty shall be submitted along with the bill. The warranty shall cover for the total equipment so that the necessity of having to approach different manufacturers of various components/assemblies does not arise and all services under warranty clause shall be the responsibility of the ultimate supplier of the composite equipment. You will also replace the defective parts, if any, during the warranty period free of cost. The responsibility to collect the defective / rejected material will lie with the supplier and the cost for such collection will have to be borne by the supplier.

9. **PENALTY FOR DELAY IN SUPPLY (L. D. CLAUSE):** The delivery of stores stipulated in Purchase order shall be deemed to be of the essence of the contract and delivery of the stores must be completed by the date specified. No materials should be supplied beyond the specified delivery period, unless specific approval has been obtained from this office.

In the event of failure to deliver the stores within the stipulated date/ period in accordance with the samples and/or specification mentioned in the supply order, and in the event of breach of any terms and conditions mentioned in the supply order Bharat Coking Coal Limited reserves the right:



(a) To recover from you, as agreed liquidated damages, a sum not less than 0.5% (half percentage) of the price of the stores which you have not been able to supply (for this purpose part of a unit supplied will not be considered) as aforesaid for each week or part of a week during which the delivery of such stores may be in arrears limited to 10%. Where felt necessary the limit of 10% can be increased to 15% at the discretion of Head of the Materials Management Division.

b) To cancel the supply order or a portion thereof, and if so desired to purchase the store at your risk and cost and also

(c) To purchase elsewhere, after due notice to you, on your account and risk, the stores not supplied or others of a similar description without canceling the supply order in respect of consignment not yet due for supply or

(d) To extend the period of delivery with or without penalty as may be considered fit and proper. The penalty, if imposed shall not be more than the agreed liquidated damages referred to in clause (a) above.

(e) To encash any Bank guarantee which is available for recovery of the penalty or

(f) To forfeit the security deposit full or in part.

The details of your bank account shall be mentioned in your Bill to facilitate e-payment.

TECHNICAL REQUIREMENT AND SPECIFICATIONS
Technical Specification for Bottom Roller

1. Bottom Roller of Vishwa make 1200 mm, belt conveyor – Qty – 1500 nos with following specification:

- a. Shell Length – 1400 mm
- b. Overall length – 1452 mm
- c. Shell diameter – 114.3 mm
- d. Shell thickness – 5.4 mm (+/-5%)

1.a	Life greased Bottom roller/Idler generally conforming to IS: 8598 -1987 (Reaffirmed in 1998 with latest amendments) (Idler and Idler Set) of different sizes of Belt Conveyor. The idler should conform to the sizes and dimensions as per enclosed Sketch no BCCL/MND/E&M/Roller/2018/1
1.b	Tube /Shell
	Tube/ shell shall be ERW MS Tube conforming to Grade YST 210 as per IS: 9295 as recommended in IS: 8598 for manufacturing of Idlers. Outside diameter shall as per our drawing. +ve Tolerance as per IS. No negative tolerance is acceptable in respect of OD & wall thickness of tube. Wall thickness of tubes should be 5.4 mm. Machining for fitting of bearing housing would be done by concentric double ended boring machine. Inside tube boring shall be done on both sides simultaneously.
2	Shaft
	Shaft shall be made of carbon steel EN-8 (BS -970) or C 40 (IS: 1570). Shaft diameter shall be as per drawing. Shaft shall be ground finished J6 (MIN) of IS: 919 at bearing seating. Machining shall be done for coaxially of both end bearing. Spindle ends shall be as per drawing/ IS: 8598 for proper fitment.
3	Bearing Housing
	Bearing housing shall be made of CRCA sheet of deep drawing quality of 3.15 mm sheet. Minimum thickness at flange after machining for bearing would not be less than 2.5 mm Bearing seat would be honed to M 7 (MIN) as per IS: 919. Bearing housing is to be press fitted. Bearing housing concentricity for both sides would be maintained. Bearing housing shall be welded to the tubes by automatic welding process (CO2 automatic welding).
4	Bearings
	Seize resistant bearings of SKF/ZKL/Timken/FAG/NTN make would be used. The minimum design rated life of bearing should be 30,000 working hours.
5	Grease/Greasing
	Hi-Lithium based grease shall be used. To ensure guaranteed bearing life for 30,000 working hours.
6	Sealing
	Protection against ingress of dust, water and cut flow of grease would be taken through different types of seals. Sealing method shall be efficient, low friction, long lasting. Multi lip type of seal would be provided to avoid ingress of dust & water.
7	Testing
	Roller shall be tested for Friction factor test; Dust Ingress test, Static balancing / eccentricity test, Water - resistance test, Idle run test for 48 hours at 300 rpm for (i) Temperature rise (ii) Any undue sound (iii) leakage of grease. Test report for all such test shall be provided by the supplier along with each consignment.
8	Painting
	One coat of Red Oxide paint and one coat of synthetic enamel grey color paint would be given on Idlers (exposed surface)



9	Fitment Guarantee
	Roller shall be made as per drawing for proper fitment. supplier are expected to take measurement of the roller at site. Bidder/supplier shall ensure proper fitment of roller.
10	Identification Mark: Maker's Name & manufacturing year.
11	Inspection will be carried out on samples. Sample size will be based on the supplied quantity and acceptance of the lot will be based on sample inspection.

We, the (Name of the Bank) do hereby agree that any demand made by Purchaser on the Bank shall be conclusive as regards the amount due and payable by the Bank under this Guarantee. We shall not withhold the payment on the ground that the supplier has disputed its liability to pay or has disputed the quantum of amount or that any legal proceeding is pending between the Purchaser and the Supplier regarding the claim. However, our liability under this Guarantee shall be restricted to an amount not exceeding Rs.
