2. PRICE VARIATION CLAUSE: The above price is variable and shall be governed by the following PVC formula –

“For every increase /decrease in price of Rs.1000/-(Rs. One thousand only) Per MT in price of copper wire bar (CC Rod 8mm standard), the price of shot firing cable per coil of 100 mtrs will increase /decrease by Rs.2.00 (Two) only. The Price variation shall not be allowed after scheduled delivery period in case of upward trend and in case of reduction, the benefit should be passed on to BCCL. For calculation of price variation of shot firing cable HCL price of 8 mm CC Copper Rod ruling on 1st working day of calendar month prior to the month of delivery shall be taken in to consideration”.

PVC Ceiling: + / - 30%.

BASE DATE for Price of 8 mm CC Copper rod as per HCL Circular/Price list shall be one month prior to the tender opening month. The above basic rates are with base date price of 8 mm CC Copper Rod for August 2017 as circulated by HCL.

3. MARKING: Brand name – LoadKing, ISI Certificate Marking will be printed on body of the cables at regular intervals.

4. GST:

- (a) GST shall be paid extra as legally applicable during the scheduled delivery period. Present rate is 28 % (IGST).
- (b) The invoice shall be raised by you should contain following elements as per Section 31 of CGST ACT, 2017 and GST Invoice, Credit and Debit Note Rules, 2017.
- name, address and GSTIN of the supplier;
 - a serial number of Invoice (should not be hand-written)
 - date of its issue;
 - name, address and GSTIN or UIN;
 - name and address of the recipient and the address of delivery, along with the name of State and its code;
 - HSN code of goods or Accounting Code of services;
 - Description and quantity of goods or services; ☒ total value of supply of goods or services or both;
 - taxable value of supply of goods or services or both taking into account discount or abatement, if any;
 - rate of tax as well as amount of tax; (central tax, State tax, integrated tax, Union territory tax or cess)
 - place of supply along with the name of State, in case of a supply in the course of inter-State trade or commerce;
 - address of delivery where the same is different from the place of supply;
 - whether the tax is payable on reverse charge basis; and
 - Signature or digital signature of the supplier or his authorized representative
- (c) You have to ensure proper uploading in your return so that BCCL may be able to avail Input Tax Credit.
- (d) You have to ensure that if BCCL does not be able to avail Input Credit due to your fault then the loss amount shall be recovered from your bill.
- (e) The benefit of any extra input tax credit earned by you, if any, in future shall be passed on to BCCL.
- (f) E-Way bill, if required, shall be arranged by you

DELIVERY PERIOD: Within 45 Days, Which shall be reckoned from the 10th day from the date of issue of supply order and the date of receipt of materials at our stores at the designated sites shall be treated as the date of delivery. Safe arrival of materials shall be the responsibility of the supplier.

7. PAYMENT TERMS: 100 % payment shall be made within 21 days after receipt and acceptance of materials by the consignee or from the date of receipt of Bills by the consignee, whichever is later.

8. PAYING AUTHORITY: HOD (F) MM, BCCL HQ.

9. SECURITY MONEY: To be submitted against RC.

10. INSPECTION: Final inspection shall be carried out at the consignee's end after receipt of materials by the concerned Technical Head or their authorized representative.

11. TRANSIT INSURANCE: Shall be arranged and covered by you for safe arrival of the materials to the consignee end at your cost and risk.

12. SUBMISSION OF BILL: Pre –receipted stamped original bill for 100% value in four copies along with, delivery challan in original, Guarantee/ Warranty certificate, and other relevant documents should be submitted to the Paying Authority through Consignee only.

13. GURANTEE /WARRANTY:

The supplier shall guarantee for the satisfactory performance of the complete stores for a period of 12 months from the date of use or 18 months from the date of receipt and acceptance of the materials, whichever is earlier.

In the event of any defects in materials, design and workmanship during the aforesaid period is found due to faulty design or poor workmanship, the defective part or parts will be replaced by the supplier at site free of cost within 30 days of settlement of warranty claims. You will be required to stock spare parts to take care of warranty failures. Spares should be available within 2 weeks of the breakdown being intimated to you.

14. CONSIGNEE: Depot officer, Central stores, Ekra, Dist. Dhanbad, Jharkhand

All other terms and conditions of the order shall be as per above referred RC.

- ISI marked multi shot firing cable twine core (parallel twins) to be used in coal mines.
- Conductor: Electrolytic grade bright copper, plain annealed conforming to IS 8130/1984.
- Nominal Cross Section Area: 01(one) sq. mm.
- Minimum no. of wires: seven.
- Insulation: PVC "A" compound conforming to IS 5831/84.
- Colour: White.
- Conforming IS: The cable shall strictly conform to IS 5950/84, latest amended if any. Type –I.
- Reel Length shall be 100 Mtrs (-) 5% to (+) 2% suitable packed in plastic sheet to protect against ingress of water.
- Current Rating of the Cable at 35°C ambient temperature – 1.2A
- Max Resistance of Conductor at 20°C (Ohm/KM) – 17.8
- Approx Net Weight of Cable (Kg/KM) – 30
- Sheath Thickness – 0.8 mm
- Approx Overall Diameter of Cable – 2.7 mm
- Cable shall bear ISI mark.
