4. **PACKING & FORWARDING: NIL**

5. **FREIGHT & INSURANCE:** extra as indicated in scope of supply.

6. **PAYMENT TERM:** 100 % payment within 21 days from the date of receipt and acceptance of materials or date of submission of bill whichever is later at the consignee end. Payment will be made through electronic fund transfer (EFT) and Electronic clearance system (ECS).

Note: Payment shall be released after submission of PBG as per Order terms.

7. **DELIVERY PERIOD:** within 90 days from the date of receipt of purchase Order, The delivery schedule will be counted from the 10th day of the date of order and the date of receipt of materials at our stores shall be treated as the date of delivery and as per NIT. The Supplier shall submit duly notarized & self attested copy of main DGMS Approval as well as revised version of the same, at the time of supply of the Methanometer. Normally extension of delivery period will not be granted. However, in case extension of delivery period becomes essential, the supplier will send their request for extension of delivery period to the purchaser before expiry of delivery period. In the event of failure to supply the ordered material within the stipulated delivery schedule, the successful tenderers must obtain extension of delivery period, with or without liquidated damage, before dispatch/supply of the ordered goods. Supplies made without obtaining extension of delivery period shall be liable for non-acceptance at the stores.

8. **GUARANTEE/ WARRANTY:** The firm shall guarantee that the material offered shall meet the rating & performance requirement stipulated in this specification. Methanometer supplied (except Sensors) should be guaranteed for a period of 12 months from the date of fitment or 18 months from the date of receipt and acceptance at consignee end whichever is earlier. For sensors the guaranteed period will be 2 years from the date of fitment. Any defect observed on this account shall be attended to immediately and in no case beyond a period of one month.

9. **PENALTY FOR DELAY IN SUPPLY (L. D. CLAUSE):** The delivery of stores stipulated in Purchase order shall be deemed to be of the essence of the contract and delivery of the stores must be completed by the date specified. No materials should be supplied beyond the specified delivery period, unless specific approval has been obtained from this office.

In the event of failure to deliver the stores within the stipulated date/ period in accordance with the samples and/or specification mentioned in the supply order, and in the event of breach of any terms and conditions mentioned in the supply order Bharat Coking Coal Limited reserves the right:

(a) To recover from you, as agreed liquidated damages, a sum not less than 0.5% (half percentage) of the price of the stores which you have not been able to supply (for this purpose part of a unit supplied will not be considered) as aforesaid for each week or part of a week during which the delivery of such stores may be in arrears limited to 10%. Where felt necessary the limit of 10% can be increased to 15% at the discretion of Head of the Materials Management Division.

b) To cancel the supply order or a portion thereof, and if so desired to purchase the store at your risk and cost and also

(c) To purchase elsewhere, after due notice to you, on your account and risk, the stores not supplied or others of a similar description without canceling the supply order in respect of consignment not yet due for supply or

(d) To extend the period of delivery with or without penalty as may be considered fit and proper. The penalty, if imposed shall not be more than the agreed liquidated damages referred to in clause (a) above.

(e) To encash any Bank guarantee which is available for recovery of the penalty or

(f) To forfeit the security deposit full or in part.

(g) Whenever under the contract a sum of money is recoverable from and payable by you, BCCL shall be entitled to recover such sum by appropriating, in part or whole by deducting any sum or which at any time thereafter may be due you in this or any other contract with Bharat Coking Coal Ltd. or any subsidiary of Coal India Ltd. Should this sum be not sufficient to cover the full amount recoverable, you will pay BCCL on demand the remaining amount. You will not be entitled to any gain under this clause

10. **SECURITY DEPOSIT:** You will be required to deposit as security money 10% of the value of the contract (including Taxes, duties, and other charges to the FOR Destination prices in case of orders in INR and in case of IMPORT Order by adding the estimated amount of freight, Insurance, Port Insurance and Custom Duties etc. as applicable) without having any ceiling in the form of Bank Draft /Bank Guarantee (As per format given in Annexure F) within 15 days from the date of order. The validity of B.G. will be for a period of three months beyond the expiry of delivery period. If the successful tenderer fails to deposit the security deposit within 15(fifteen) days from the date of order, the same shall be recorded as unsatisfactory performance for future dealings apart from taking any other penal action as may be deemed fit by BCCL. For successful tenderers, the Security Money shall be refunded within 30 days of satisfactory execution of contract. For unsatisfactory execution of contract and/or failure of execution of contract, the security money shall be forfeited. For orders with Performance Bank Guarantee Clause, the Security Deposit shall be refunded after successful completion of the supply/commissioning (wherever applicable) and against receipt of the acceptable performance Bank Guarantee.

11. **PERFORMANCE BANK GUARANTEE:**

PBG on schedule / Nationalized Bank in India valid for three months beyond the expiry of Guarantee/Warranty period for 10% value of the supply order (by adding GST etc. to the FOR destination price of the items ordered) shall have to be submitted to MM Division, BCCL, Koyla Bhawan on or before commencement of supply

The original Bank Guarantee should be sent to the beneficiary directly by the issuing bank under registered post with A.D

However in exceptional cases, where the Bank Guarantee is handed over to the customer for any genuine reasons, the issuing bank should immediately send by Registered Post with A.D an unstamped duplicate copy of the BG directly to the beneficiary with a covering letter requesting them to compare with the original received from supplier and confirm that it is in order. The A.D card should be kept with the loan papers of the relevant BG.

The Performance Bank Guarantee shall be released after fulfillment of all contractual obligations including warranty /guarantee conditions stipulated in the contract. For unsatisfactory performance and/or contractual failure, BCCL shall have the full right to invoke/en-cash the Performance Bank Guarantee.



Technical Specification for DGMS Approved Methanometer

- 1) Methanometer should be DGMS approved and conforming to IS/IEC60079-1:2007. It should be compact, portable, light weight, hand held and intrinsically safe for use in underground mine for the determination of percentage of Methane and other inflammable gases in the general body of the air.
- 2) The Supplier shall have valid DGMS approval (main & revised thereof) on the date of opening of Tender as well as on the date of supply of material to the Consignee for using in degree I, II and III gassiness mines for continuous monitoring of Methane and other inflammable gases in general body of air.
- 3) The DGMS Approval No. Should be marked/engraved/embossed on the body of Methanometer.
- 4) The Supplier shall submit duly notarized & self-attested copy of main DGMS Approval as well as revised version of the same, with the offer as well as at the time of supply of the Methanometer.
- 5) Measurement range of the instrument should be 0(zero) to 5 (five) vol % of Methane.
- 6) The Methanometer without charger and probe shall be portable, pocket size and display should be digital. The instrument shall be with audio visual alarm if % of methane exceeds 1.25% in general body of air
- 7) All fault messages & gas concentrations values shall be stored in the instruments Internal Memory for later analysis.
- 8) The samples of the supplied instruments shall be tested at any Govt Approved Test House for which cost will be borne by the supplier & if the test result is not satisfactory the whole lot will be rejected without making any payment for the lot.
- 9) The Methanometer shall be digital, rechargeable & with telescopic attachment with aspirator.
- 10) The Methanometer shall be fit for use in all degree of gassiness.
- 11) Service along with calibration facility after sale should be available locally at Dhanbad. Name of the local contact persons with complete address & Mobile / Telephone Number must be mentioned in the offer.
- 12) The instrument should be able to work effectively in atmospheric temperature up to 50°C and relative humidity of upto 95%
- 13) Life of Equipment offered is to be quoted by the bidder. The minimum life of the equipment should be 5 years.
