

 With reference to the above, we for and on behalf of BCCL hereby place **PURCHASE ORDER** on you for supply of Colour Demy Paper for BCCL at following price, terms and conditions indicated below:

- EXCISE DUTY:** Not Applicable. If applicable during pendency of this contract it will be borne by the firm.
- J-VAT:** Payable Extra as applicable within the stipulated delivery schedule. Present rate of J-VAT is @ 5%.
- PAYMENT TERMS:** 100% Payment shall be made within 21 days after receipt and acceptance of materials at site or submission of Bill whichever is later.
- DELIVERY PERIOD:** Supply shall be completed within 01 (one) month from the date of issue of Purchase Order. However early delivery will be appreciated. Delivery is the essence of this contract.
- SECURITY DEPOSIT:** Not Applicable.
- PAYING AUTHORITY:** CM(Fin)/C Pay, Koyla Bhawan, Dhanbad
- CONSIGNEE:** DGM(Admin), Koyla Bhawan, Dhanbad

**8A. ALLOCATION: BCCCL PRESS**

**9. INSPECTION CLAUSE:** Inspection shall be carried out at Consignee's end by DGM (Admin) or his authorized representative.

**NOTE : You will ensure safe & sound delivery of stores at consignee's end.**

**10. PENALTY FOR FAILURE TO SUPPLY IN TIME:** The delivery of stores stipulated in Purchase order shall be deemed to be of the essence of the contract and delivery of the stores must be completed by the date specified. No materials should be supplied beyond the specified delivery period, unless specific approval has been obtained from the purchaser. In the event of failure to deliver the stores within the stipulated date/ period in accordance with the samples and/or specification mentioned is the supply order, and in the event of breach of any terms and conditions mentioned in the supply order, Bharat Coking Coal Limited reserves the right:

- a) To recover from successful tenderer, as agreed liquidated damages, a sum not less than 0.5% (half percentage) of the price of the stores which successful tenderer has not been able to supply (for this purpose part of a unit supplied will not be considered) as aforesaid for each week or part of a week during which the delivery of such stores may be in arrears limited to 10%. Where felt necessary the limit of 10% can be increased to 15% at the discretion of Head of the Materials Management Division.
- b) To purchase elsewhere, after due notice to the successful tenderer on the account and at the risk of the defaulting supplier the stores not supplied or others of a similar description without cancelling the supply order in respect of consignment not yet due for supply or
- c) To cancel the supply order or a portion thereof, and if so desired to purchase the store at the risk and cost of the defaulting supplier and also
- d) To extend the period of delivery with or without penalty as may be considered fit and proper. The penalty, if imposed shall not be more than the agreed liquidated damages (referred to in clause (a) above).
- e) To encash any Bank guarantee which is available for recovery of the penalty
- f) To forfeit the security deposit full or in part.
- g) Whenever under the contract a sum of money is recoverable from and payable by the supplier, BCCCL shall be entitled to recover such sum by appropriating, in part or in whole by deducting any sum or which at any time thereafter may be due to the successful tenderer in this or any other contract with Bharat Coking Coal Ltd. or any subsidiary of Coal India Ltd. Should this sum be not sufficient to cover the full amount recoverable, the successful tenderer shall pay BCCCL, on demand the remaining amount. The supplier shall not be entitled to any gain under this clause.

**11. PRICE FALL CLAUSE:**

i) The prices charged for the stores supplied under the contract by the supplier shall in no event exceed the lowest price at which the supplier offer to sell the stores of identical description to any other organization from date of offer till completion of supply under the contract.

ii) If at any time during the said period the supplier offers lower sale price of such stores to any other organization at a price lower than the price chargeable under this contract, the supplier shall forthwith notify such reduction or sale to the consignee concerned under intimation to CGMM/ML, Bharat Coking Coal Limited - Commercial Block, Level -III, Koyla/Bhawan, Koyla Nagar, Dhanbad and the price payable under the contract for the stores supplied after

the date of coming into force of such reduction or sale, shall stand correspondingly reduced. The above stipulated will not, however apply to exports by the supplier.

**12. LOWEST PRICE CERTIFICATE:** You shall submit a certificate along with bill as stated below:

"The rates of the stores under this contract are the lowest at which we are selling to any other Customer / Govt. Deptt./ Subsidiaries of CIL/ Other PSUs . If the materials are sold at any lower rate than that mentioned in this contract to any other agency , the same will automatically be applied to this contract from that date".

**13. SUBMISSION OF BILL:** Pre-received stamped original bill for 100% value in five copies along with, delivery challan in original, Guarantee/ Warranty certificate, and other relevant documents should be submitted to the Paying Authority through Consignee only.

**14. GUARANTEE / WARRANTY:** Material shall be covered under Standard Manufacturer Guarantee/Warranty as per standard norms of manufacturer and it should be free from any manufacturing defect. If any defect is found in the materials you will have to arrange for replacement of the same free of cost immediately within 30 days from the date of receipt of complaint. A certificate to this effect shall be furnished by you.

**15. PACKING:** Consignment shall be supplied in suitable standard proper packing.

**16. FORCE MAJEURE CLAUSE:** If the execution of the supply order is delayed beyond the period stipulated in the supply order as a result of out-break of hostilities, declaration of an embargo / curfew or blockade or fire, flood, acts of nature or any other contingency beyond the supplier's control due to act of God then BCCIL may allow such additional time by extending the delivery period, as it considers to be justified by the circumstances of the case and its decision shall be final.

**ALL DISPUTES ARE SUBJECT TO DHANBAD COURT AND JHARKHAND HIGH COURT JURISDICTION ONLY.**

This contract is concluded with the issuance of this supply order. We are enclosing 2 copies of the supply order, one of which should be returned to us duly stamped and signed. This /issues with the approval of the Competent Authority.
