Terms & Conditions: -

1.) Basis of Price: Prices are FIRM and on FOR Destination basis inclusive of Packing & forwarding, Freight & insurance charges up to destination stores.

2.) GST: (a) GST shall be paid extra as legally applicable during the scheduled delivery period. Present rate of GST is 18% & 28% as mentioned above. The firm shall raise Tax Invoice as per GST Act / rules, so as to avail Input Tax Credit by BCCL.

- (b) You have to ensure proper uploading in your return so that BCCL may be able to avail Input Tax Credit.
- (c) If BCCL does not be able to avail Input Credit due to fault of the supplier then the loss amount will be recovered from the supplier.
- (d) The benefit of any extra input tax credit earned by you, if any, in future shall be passed on to BCCL.
- (f) E-Way bill, if required, shall be arranged by you.
- (NB: Any increase in taxes & duties beyond the stipulated delivery period will be to your account).

3.) Warranty/Guarantee: You will give Warranty/Guarantee for satisfactory performance of the supplied materials for a period of 12 months from the date of fitment or 18 months from the date of receipt and acceptance of material at consignee's end whichever is earlier.

You shall be responsible for any defect that may develop under the conditions provided for by the contract and under proper use, arising from faulty materials, design or workmanship and shall remedy such defects at your own cost when called upon to do so. If it becomes necessary for you to replace or renew any defective part, such replacement or renewal shall be made by you 100% free of cost without any extra cost to BCCL.

In the event of any defect in materials/ design and workmanship during the aforesaid period is found due to faulty design or poor workmanship, the defective items will be replaced by you at site free of cost within 30 days of settlement of warranty claims. You will be required to stock items to take care of warranty failures. Items should be available within 2 weeks of the breakdown being intimated to them. The guarantee / composite warranty shall be submitted along with the bill.

The warranty shall cover for the total stores so that the necessity of having to approach different manufacturers of various components / assemblies does not arise and all services under warranty clause shall be the responsibility of the ultimate supplier of the composite stores. You will also replace the defective items, if any, during the warranty period free of cost. The responsibility to collect the defective / rejected material will lie with you and the cost for such collection will have to be borne by you.

4.) Fitment Guarantee: You will furnish a fitment guarantee certificate along with the supply that the items supplied by you against supply order are exact replacement of / fully interchangeable to original parts on one to one basis and will fit & function properly in the equipment for which these are intended for without any modification / alteration to the existing system of the equipment running in BCCL and conforms to performance guarantee as per OEM standards. You will replace free of cost the materials, in case the supplied items do not fit & function properly and warranty period will be counted from this date of warranty replacement.

5.) Identification Marks: Supplied materials should either have embossing or print, indicating manufacturer's name / logo at visible place which is not subject to normal wear and tear for convenience of identification at any point of time.

6.) Delivery: Supply to be completed within **90 days** from the date of issue of supply order. The delivery period shall be reckoned from the 10th day of the order date. However early delivery will be preferred.

7.) Payment Terms: 100% payment within 21 days of receipt and acceptance of materials at destination stores or submission of bills whichever is later. BCCL shall be making payment through electronic fund transfer/RTGS system.

8.) Submission of bill(s) & Documents: -Bill against the supplies made shall be submitted by you as under:

- (A) Paying Authority: Pre-receipted bill in quadruplicate along with receipted Challan, certificates specified in the order.

- (B) Consignee: (i) Copy of bill, (ii) Inspection note (original) if applicable, (iii) Originals of all Test Certificates specified in the order, (iv) Copy of consignment note along with invoice, (v) Authenticated copies of all other documents specified in the order.
- (C) GM (MM) & GM (Excv): (i) Copy of bill, (ii) Copy of consignment note if applicable, (iii) Copy of inspection note if applicable, (iv) Copy of authenticated copies of all other documents specified in the order.

9.) (a) **Allocations:** Area wise quantity allocation detailed as per Annexure – I.

9.) (b) **Consignee:** Depot officer, Regional Stores – Barora Area, Block-II Area, Katras Area, Sijua Area, Kusunda Area, Bastacolla Area, Lodna Area and CV Area, BCCL, Dhanbad.

10.) **Paying Authority:** HOD (F) MM, Pur. - Fin., BCCL, Dhanbad.

11.) **Lowest Price Certificate:** You shall submit a certificate certifying that the prices charged by you against this supply order are the lowest and are same as applicable to other Government Departments / Undertakings / Other Organisations.

You shall also certify that the prices charged are not higher than the rates quoted / prices charged by you for same / similar items to other customers.

12.) **Mode of Despatch:** The materials should be despatched to the consignee by Road on Fright paid basis through registered common carriers only as per the provisions of carriage by Road Act-2007.

13.) **Security Deposit:** You are required to deposit security money in the form of Bank Draft drawn in favour of “Bharat Coking Coal Limited” payable at Dhanbad, or by way of Bank Guarantee of any schedule Bank for 10% value of the order (value means F.O.R destination price) i.e. **Rs 6,45,108.00 within 15 days from the date of receipt of order.** In case of failure to deposit the same, the order shall be cancelled and the case shall be processed to order elsewhere and the firm's performance is to be kept recorded for future dealings with them. For unsatisfactory performance and/or contractual failure the security money shall be forfeited.

14.) **Liquidated Damage clause cum Risk Purchase clause:** In the event of failure to delivery or dispatch the stores within the stipulated date/ period in accordance with the samples and/or specification mentioned in the supply order, and in the event of breach of any terms and conditions mentioned in the supply order, Bharat Coking Coal Limited reserves the right:

- To recover from successful tenderer, as agreed liquidated damages, a sum not less than 0.5% (half percentage) of the price of the stores which successful tenderer has not been able to supply (for this purpose part of a unit supplied will not be considered) as aforesaid for each week or part of a week during which the delivery of such stores may be in arrears limited to 10%. Where felt necessary the limit of 10% can be increased to 15% at the discretion of head of the Materials Management Division.
- To purchase from elsewhere, after due notice to the successful tenderer on the account and at the risk of the defaulting supplier the stores not supplied or others of a similar description without cancelling the supply order in respect of consignment not yet due for supply or
- To cancel the supply order or a portion thereof, and if so desired to purchase the store at the risk and cost of the defaulting supplier and also
- To extend the period of delivery with or without penalty as may be considered fit and proper. The penalty, if imposed shall not be more than the agreed liquidated damages referred to in clause (a) above except in case of force majeure condition.
- To forfeit the security deposit full or in part.
- Whenever under the contract a sum of money is recoverable from and payable by the supplier, BCCL shall be entitled to recover such sum by appropriating, in part or whole by deducting any sum or which at any time thereafter may be due to the successful tenderer in this or any other contract with Bharat Coking Coal Ltd. or any subsidiary of Coal India Ltd. Should this sum be not sufficient to cover the full amount recoverable, the successful tenderer shall pay BCCL on demand the remaining amount.

15.) PRICE FALL CLAUSE: If you, at any time during the tenure of the order, supply materials of identical description in India, to any customer including CIL (or its subsidiary Cos.) at a price lower than the price stipulated in the present purchase order, you shall forthwith notify to BCCL such reduction in sale price of materials and BCCL shall amend its order price to lower price. In the event of non-intimation by the seller to this effect, suitable penal action may be considered against you.

16.) Jurisdiction: The Court at Dhanbad in Jharkhand State only will have the jurisdiction to deal with & decide any legal matter or dispute whatsoever arising out of our contract.

17.) Inspection: Final Inspection shall be carried out at consignee end as per terms & Condition of RC (SECL RC Ref no. 177 Dtd 29.01.2019), by the rep of user dept.


