11. Payment terms: 100% payment will be made within 21 days of receipt and acceptance of the materials by the consignee or from the date of receipt of Bills, whichever is later.

12. Submission of Bill: 100% value of bill duly stamped, signed & pre-receipted in quadruplicate, as per order, should be submitted for payment to the paying authority through consignee.

Bill should be submitted along with challan, Consignment note (if required), packing list if any, performance/warranty certificate, fitment /Test certificate if required, proof of payment of freight charges if freight is claimed, documentary evidence of Excise duty payment if claimed, Price Certificate, Copy of Inspection Note of CMPDIL (If required) and other documents as per order.

(Note - All documents to be submitted shall be duly authenticated)

Payment will be made without submission of performance Bank Guarantee & security deposit, if specified in order.

13. Warranty /Warranty: As per annexure 'A' and Materials supplied should be guaranteed for a period of 12 (twelve) months from the date of fitment or 18 months from the date of receipt and acceptance at consignee and, whichever is earlier, against any manufacturing defects / workmanship and/or quality. Any defect observed on this account shall be attended within 07 days from the date of receipt of report and replace the materials within 21 days free of cost.

14. Best Price Certificate: You should submit a certificate along with bill as stated below:

"The prices of the stores under this contract are the lowest at which we are selling to any other agency/ Govt. Deptt. / Subsidiaries of CIL/ Other PSUs. If the materials are sold at any lower rate to any other agency, the same will automatically be applied to this contract from that date."

15. Performance Bank Guarantee: Not Required.

16. Security Deposit: Exempted as Submitted NSIC

17. Inspection: Final inspection shall be carried out at the consignee end after receipt of materials by the consignee to clinical head or their authorized representative.

18. Failure to Supply in Time: The delivery of stores stipulated in Purchase order shall be subject to the essence of the contract and delivery of the stores must be completed by the date specified. No materials should be supplied beyond the specified delivery period, unless specific permission has been obtained from this office.

In the event of failure to deliver the stores within the stipulated date/ period in accordance with the terms and specifications mentioned in the supply order, and in the event of breach of any terms and conditions mentioned in the supply order Bharat Coking Coal Limited reserves the right:

(1) To impose on you, as agreed liquidated damages, a sum not less than 0.5% (half percentage) of the price of the stores which you have not been able to supply (for this purpose part of a unit or fraction thereof will not be considered) as aforesaid for each week or part of a week during which the delivery of such stores may be in arrears limited to 10%. Where felt necessary the limit of 10% may be increased to 15% at the discretion of Head of the Materials Management Division.

(2) To purchase elsewhere, after due notice to you, on your account and risk, the stores not supplied or others of a similar description without canceling the supply order in respect of the quantity not yet due for supply or

(3) To cancel the supply order or a portion thereof, and if so desired to purchase the store at your market cost and also

(4) To extend the period of delivery with or without penalty as may be considered fit and proper. The penalty, if imposed shall not be more than the agreed liquidated damages referred to in paragraph above.

(5) To require a Bank guarantee which is available for recovery of the penalty or

(6) To forfeit the security deposit full or in part.

- g) Whenever under the contract a sum of money is recoverable from and payable by you, BCCCL shall be entitled to recover such sum by appropriating, in part or whole by deducting any amount which at any time thereafter may be due you in this or any other contract with Coal India Ltd. or any subsidiary of Coal India Ltd. Should this sum be not sufficient to recover the amount recoverable, you will pay BCCCL on demand the remaining amount. You shall not be entitled to any gain under this clause.


19. Price fall Clause:

- i. The prices charged for the stores supplied under the contract by the supplier shall not exceed the lowest price at which the supplier offer to sell the stores of identical description to any other organization from date of offer till completion of supply under the contract.
- ii. If at any time during the said period the supplier offers lower sale price of such stores to any other organization at a price lower than the price chargeable under this contract, you shall forthwith notify such reduction or sale to the consignee concerned and to the CGM(MM), Bharat Coking Coal Limited, Commercial Block, Level -III, Koyla Bahar, Dhanbad, Jharkhand, Dhanbad and the price payable under the contract for the stores supplied hereunder, from the date of coming into force of such reduction or sale, shall stand correspondingly reduced. The provisions stipulated will not, however apply to exports by the supplier.


All other terms & conditions along with Technical Specifications and Scope of supply will apply as per our NIT and company's norms.

ALL DISPUTES ARE SUBJECT TO DHANBAD COURT AND JHARKHAND HIGH COURT JURISDICTION.
This contract is concluded with the issuance of this order. Two copies of the order is being issued. You are advised to acknowledge the receipt and acceptance of the order by returning a copy signed and stamped to this office positively within 15 days, failing which this order shall be deemed to have been accepted by you for execution.

IMPORTANT TERMS:--

1. Cage suspension gear components will be manufactured as per DGMS approved drawing, latest DGMS circulars, standards and from DGMS approved manufacturer only.
2. Materials to be used during manufacturing will be strictly as per DGMS approval/guidelines.
3. 100% items will be tested from CMRI / NTH for Proof load & NDT as per DGMS guidelines. TC in original to be submitted alongwith the supply.
4. TC for Proof Load of bridle chains from original manufacturer to be submitted alongwith the supply.
5. Copy of the drawing for the offered items duly certified by the DGMS to be submitted, or A self certification by the DGMS approved manufacturer that items offered are strictly as per DGMS approval and drawings.
6. Copy of the valid DGMS approval must be submitted at the time of execution of order.
7. Life: Life of all C S Gear components shall be as per C.M.R. 31(1) i.e. 6 years except cage pin, split pin and copper pin, which are high wear & tear items.
