- 1. Wherever the Rope is not mentioned in the IS in that case the Rope should conform to IS 2266/89 in general.
- 2. Rope must be ISI marked.
- 3. Ropes shall be supplied with test reports as per IS: 2266/89(latest)
- 4. Ordered size of rope should be supplied in one drum.
