- 1. Price:** Firm & FOR Destination basis.
- 2. Excise Duty & Ed. Cess:** Extra @12.36%. The excise invoice shall contain the provisions as per NIT for enabling BCCL to avail CENVAT credit.
- 3. P&F, Frt. & Ins.:** To be borne by the Firm
- 4. Sales Tax:** JVAT @ 14 % is extra as applicable

**5. Delivery:** Within 30 from the date of placement of Order. Both items are to be supplied in single module.

**6. Payment:** 100% within 21 days of receipt and acceptance of materials or from the date of receipt of Bill by the consignee, whichever later.

**7. Consignee:** Depot Officer, Regional Stores, Katras Area, BCCL .Dhanbad.

**8. Price Certification:** The Firm will certify on their Bills that the price charged to BCCL is not higher than the prices applicable to Govt. Deptt./PSUs/ other organizations .

**9. Warranty:** The firm shall furnish manufacturer's composite guarantee for the complete module for 2 years from the date of acceptance of items at Stores or satisfactory performance of the same in all respect for a period of 6000 hours of operation from the date of fitment on the equipment, whichever is earlier. If any defects are found due to faulty design or bad workmanship, the defective parts shall have to be replaced free of cost within 30 days of intimation by end user.

**10.L.D. Clause and Price Fall Clause:** As per Annexure-I

**11.Fitment Guarantee:** You will submit a Certificate of Fitment Guarantee of the supplied of BE1000 Hyd. Excavator Sl. no G10055, BCCL no S-368 of AKWM OCP, Katras Area without any modification(deletion/addition).The design of the item shall be exactly as per that of OEM.

**12.Logo/Identification:** Make/Symbol/Identification mark of manufacturer and part number should be clearly embossed /engraved/punched or legibly indicated on each and every item at a visible place which is not subject to normal wear and tear.

**13.After Sales Service:** You will extend after sales service to the user.

**14. Security Deposit:** Exempted being PSU

**15.Inspection :**At the consignee End for acceptance of materials

**16.Paying authority :** GM(F),Pur-Fin., MM Division Koyla Bhawan

**17.Jurisdiction:** Any disputes will have jurisdiction of Dhanbad Court & Jharkhand High Court only.

**18. Force Majeure:**If the execution of the contract/supply order is delayed beyond the period stipulated in the contract/supply order as a result of out-break of hostilities, declaration of an embargo / curfew or blockade or fire, flood, acts of nature or any other contingency beyond the supplier's control due to act of God then BCCL may allow such additional time by extending the delivery period , as it considers to be justified by the circumstances of the case and its decision shall be final. If and when additional time is granted by BCCL the contract/supply order shall be read and understood as if it had contained from its inception the delivery date as extended. Further this clause state that:

a) The successful bidder will, in the event of his having to resort to this clause by a registered letter duly certified by the local Chamber of Commerce or statutory authority, the beginning and end of the causes of the delay, within fifteen days of the occurrence and cessation of such Force Majeure Conditions. In the event of delay lasting out of Force Majeure, BCCL will reserve the right to cancel the contract and provisions governing termination of contract, as stated in the bid documents will apply.

b) For delays arising out of Force Majeure, the bidder will not claim extension in completion date for a period exceeding the period of delay attributable to the causes of Force Majeure and neither BCCL nor the bidder shall be liable to pay extra costs provided it is mutually established that Force Majeure Conditions did actually exists.

c) If any of the Force Majeure conditions exists in the place of operation of the bidder even at the time of submission of bid, he will categorically specify them in his bid and state whether they have been taken into consideration in their quotations

**19. Submission of bill:** 100 % value of bill duly stamped and pre-receipted in Six copies as per terms of order should be submitted to the Paying Authority through consignee for

payment. Bill should be submitted along with receipted Challan, fitment Certificates & packing list if any, inspection report, guarantee warranty certificate etc.

ALL OTHER REMAINING COMMERCIAL TERMS & CONDITIONS AND TECHNICAL SPECIFICATIONS ALONG WITH SCOPE OF SUPPLY WILL STRICTLY BE AS PER OUR NIT AS CONFIRMED IN YOUR OFFER AND YOUR SUBSEQUENT LETTERS.

## ANNEXURE-I

### **PENALTY FOR FAILURE TO SUPPLY IN TIME**

The time and date of delivery of stores stipulated in Purchase order shall be deemed to be of the essence of the contract and delivery of the stores must be completed by the date specified. No materials should be supplied beyond the specified delivery period, unless specific approval has been obtained from the purchaser.

In the event of failure to delivery or dispatch the stores within the stipulated date/ period in accordance with the samples and/or specification mentioned in the supply order, and in the event of breach of any terms and conditions mentioned in the supply order. Bharat Coking Coal Limited reserves the right:

*a) To recover from successful tenderer, as agreed liquidated damages, a sum not less than 0.5% (half percentage) of the price of the stores which successful tenderer has not been able to supply (for this purpose part of a unit supplied will not be considered) as aforesaid for each week or part of a week during which the delivery of such stores may be in arrears limited to 10%. Where felt necessary the limit of 10% can be increased to 15% at the discretion of Head of the Materials Management Division.*

*b) To purchase elsewhere, after due notice to the successful tenderer on the account and at the risk of the defaulting supplier the stores not supplied or others of a similar description without cancelling the supply order in respect of consignment not yet due for supply or*

c) To cancel the supply order or a portion thereof, and if so desired to purchase the store at the risk and cost of the defaulting supplier and also

d) To extend the period of delivery with or without penalty as may be considered fit and proper. The penalty, if imposed shall not be more than the agreed liquidated damages referred to in clause (a) above.

e) To encash any Bank guarantee which is available for recovery of the penalty or

f) To forfeit the security deposit full or in part.

g) Whenever under the contract a sum of money is recoverable from and payable by the supplier, BCCL shall be entitled to recover such sum by appropriating, in part or whole by deducting any sum or which at any time thereafter may be due to the successful tenderer in this or any other contract with Bharat Coking Coal Ltd. or any subsidiary of Coal India Ltd. Should this sum be not sufficient to cover the full amount recoverable, the successful tenderer shall pay BCCL on demand the remaining amount. The supplier shall not be entitled to any gain under this clause.

The supplier must confirm the acceptance of this Penalty clause, which will not be altered.

### **PRICE FALLCLAUSE**

i) The prices charged for the stores supplied under the contract by the supplier shall in no event exceed the lowest price at which the supplier sells the stores of identical description to any other organization till validity of the contract.

ii) If at any time during the said period the supplier reduces the sale price of such stores or sells such stores to any other organization at a price lower than the price chargeable under this contract, the supplier shall forthwith notify such reduction or sale to the consignee concerned under intimation to CGM (MM), Bharat Coking Coal Limited, Commercial Block, Level –III, Koyla Bhawan, Koyla Nagar, Dhanbad and the price payable under the contract for the stores supplied after the date of coming into force of such reduction or sale, shall stand correspondingly reduced. The above stipulated will not, however apply to exports by the supplier.
