8.2 The above equipments must be available all the time in the explosive factories. In the event of surprise checking by BCCL or any agencies of BCCL, if there is a deviation from the above confirmed by bidder, then the Contract shall be short closed and necessary penal action shall be taken by BCCL

#### 9. Random Testing

BCCL /CMPDIL/CMRI/PESO will conduct random testing of the explosives & its accessories supplied and in case the tendered limit of the technical parameters cannot be achieved from explosives supplied from time to time, the supply order of Explosives Cartridges & accessories placed on a supplier may be cancelled. The testing charges will be borne by the suppliers. BCCL shall submit the random test results time to time of the suppliers to HOD (Prod), BCCL/CIL for consolidating the same and updating their record of individuals firms performance. Monitoring of optimum blast design provided by the supplier shall also be done by HOD(Prodn),BCCL/CIL.

The Random Testing would be done drawing samples from the supply of explosives by a team consisting of a representative of BCCL and a representative from the Regional Institute of CMPDIL or CMRI or PESO. The test will be undertaken by CMPDIL or CMRI or PESO to check the above technical parameters. The testing charges will be borne by the suppliers.

In all cases of random sampling of explosives and accessories, the number of samples to be tested for a particular supplier shall not be less than 2 samples irrespective of prevailing practice being followed.

The supplier has to get their items checked on random basis through the facility already introduced in the BCCL or through any other subsidiary where this system has already been introduced. The random checking will be liability of the suppliers to be done on the advice of the subsidiaries concerned.

#### Sample quantity of random testing

a. **Cast Booster:** The number of samples to be tested should not be less than two samples per quarter for a particular supplier.

# 10. Performance & Penalty:

- 1. Review of the product performance shall be made on the basis of fragmentation /muck pilling costs per cuM and capacity improvement achieved for the total system. In the event of your item not providing satisfactory results, penalty will be imposed by way of Price Reduction/Quantity Reduction/Withdrawal of these items.
- 2. In the event of failure of blast, the cost of explosives/accessories used in the blast and other incidental charges like drilling cost etc. will be recovered from the respective defaulting supplier(s). In Case of blast failure, initially proportionate deduction (proportionate to value) will be made for both explosives and accessories. After investigation into the cause of failure as to which item (explosive or accessories) is responsible for the failure, final deduction will be made accordingly.

## 11. Technical service

- 11.1 Whenever a manufacturer supplies any explosives / accessories (*tendered items*) item for the first time to a subsidiary, CMPDIL test and trial report of that item shall be presented to the CGM/GM (Prodn) of the subsidiary co. before the explosives and accessories (*tendered items*) are used in any colliery and the manufacturer's representative shall be available for advice.
- 11.2 At least one technical representative shall be posted in each subsidiary.
- 11.3 The technical representative of a supplier shall report to user within 48 hours of call (letter/fax/mail/ SMS) and failure to reach the caller within 48 hours shall attract a penalty of Rs 15,000/-. Calls shall also be endorsed to CGM / GM in charge of the explosives at subsidiary headquarters level who will finally decide on imposition of penalty.
- 11.4 The manufacturer shall give technical expertise in designing the pattern of blast holes to improve the blasting efficiency depending upon the requisition by the subsidiary.
- 11.5 Whenever there is a special problem like vibration and noise near any structure or dwelling, technical representative from the manufacturer shall immediately attend to them and solve the problem jointly with the mine representative.
- 11.6 Half yearly workshop/training shall be conducted by the suppliers to explain the technical details of their item as well as to make the people understand and implement the uses of the explosives and accessories (*tendered items*) for safe and efficient operation and for improvement of blasting efficiency.
- 11.7 Quarterly technical service report shall be submitted by the supplier to the concerned subsidiary companies.
- 12. The manufacturer of all kinds of detonators/non electric detonators shall follow a system by which the electrical continuity, resistance testing & other tests shall be ensured by them and they shall give a certificate accordingly, in addition to the conditions to be complied with, in reference to the permission being accorded to the respective manufacturers by DGMS/PESO.
- 13. The bidder shall give item wise list of users, other than CIL, of their offered items during the period 2011-12.
