

- Note: i) All DDOs are requested to place orders against this Rate Contract as per their Approved requirements only after obtaining competent Approval and financial concurrence from their respective Area Finance Managers.
- ii) All the DDOs must place bulk order(s) to the Division Manager as per their convenience well in advance. The payment should be made only after acceptance of the order by the DM and inspection of timber in their depots.
- iii) All the DDOs must submit the quarterly report to the office of GM (MM), and GM(Safety) with respect to the value of order for timber placed and the value of timber supplied in a quarter by WB Forest Development Corporation Ltd.
- iv) The availability of Timber during monsoon period (June to October) is almost nil. The DDO's/Consignee must ensure that the timbers required for these period are collected well within time.
