1.Payment Terms:- 100% within 21 days of receipt and acceptance of the materials by the consignee or from the date of receipt of Bill whichever is later by the consignee.

2. **Prices:-** FIRM and FOR Destination except Govt. taxes & duties which shall be paid extra as applicable at the time of dispatch subject to documentary evidence, within the specified delivery period.

3. **DELIVERY SCHEDULE:-** To commence within 20 days which shall be reckoned from 10th day of placement of order and to be supplied @ 10000 nos. per month thereafter . However , earliest delivery will be highly appreciated .

Any increase in the rate of taxes & duties beyond delivery period will be to your account.

NOTE: Safe arrival of materials shall be your responsibility.

4. **Security Money:-** Exempted being Registered with NSIC.

5. **Inspection:-** The inspection will be done at consignee's end on receipt of materials by the concerned technical head or their authorized representative.

6. **Packing ,Forwarding,Freight & Insurance Charges:-** Inclusive.

7. **Mode of Despatch:-**By Road on F.O.R. Destination , Freight paid basis .

NOTE : Safe & sound delivery of stores at consignee's end must be ensured .

8. **Excise Duty & Cess :-** NIL

9. **CST :-** Extra @ 2% against issuance of form 'C' by consignee.

10. **Price Certificate :-** As per R/C.

11. **Price Fall Clause :-** As per R/C.

12. **Penalty for failure to supply in time:-** As per R/C.

13. **Transit Insurance:-** Shall be arranged and covered by you for safe arrival of the materials to the consignee end at your cost and risk.

15. **Guarante/Warranty:-** The bulbs shall be covered by the maker's standard guarantee :

Bulbs should be new , unused and of current design , not likely to be discontinued or become obsolete till the life of the offered equipment .

The bulbs must be strictly as per the specification and free from any defect in material and workmanship . The purchaser is free to test bulbs supplied by you and you will replace whenever found not satisfactory . The life of bulbs must be minimum 200 working hours as per I.S.I.

In the event of any defect in materials , design and workmanship of material , the defective part or parts will be replaced free of cost within 30 days .

16. **Monthly Statement or orders & deliveries:-** The firm should submit a statement of receipt of orders from different DDOs and supply status thereof, by 7th of each month to the office of the GM(MM)(PUR), Koyla Bhawan, Dhanbad.

17. **Packing:-** Consignment shall be supplied in suitable standard proper packing.

18. **Submission of Bill** : 100% value of bill duly stamped , signed & pre-receipted in quadruplicate , as per terms of the order should be submitted for payment to the paying authority through consignee.

Bill should be submitted along with challan, Consignment note (if required) , packing list if any, guarantee/warranty certificate, fitment / Test certificate if required , proof of payment of freight charges if freight is claimed , documentary evidence of Excise duty payment if claimed, Price Certificate and other documents as per order .
