Terms and conditions :

- i) Firm and FOR Destination and firm till completion of supply
- ii) Packing forwarding, freight and insurance charges up to destination- To be borne by supplier
- iii) Excise duty Inclusive ,Refund credit if any obtained shall be passed on to the buyer (BCCL) shall be certified by your auditor and to be submitted along with the bill.
- iv) JVAT : Extra as applicable within scheduled delivery period @14 % against JVAT form

- v) Paying Authority : AFM ,Area –III , Govind pur Area ,BCCL Dhanbad
- vi) Consignee : Depot Officer , Govind pur Area , Area-II I, BCCL , Dhanbad
- vii) Warrantee/Guarantee : The supplier shall give a warranty for satisfactory performance of the supplied material for a period of 12 months from the date of commissioning or 18months from the date of receipt and acceptance at consignee's end whichever is earlier. The supplier shall be responsible for any defect that may under the condition provided for by the contract and under proper use, arise due to faulty materials design or workmanship and shall remedy such defects at his own cost. If it becomes so necessary for the suppliers to replace or to renew any defective part, such replacement or renewal shall be made by the supplier 100% free of cost without any extra cost to BCCL. The new goods should be supplied on FOR destination basis free of cost.

Warranty replacement should be completed within a reasonable period maximum within 1 month from the date of claim for indigenous goods and within 3 months from the date of claim for imported goods free of cost up to ultimate consignee's end. All cases of warranty replacement will be decided on the basis of joint inspection of the failed goods held between the user's representative and the manufacturer's representative. The supplier is also requested to certify that their products are exact replacement of/fully interchangeable to the original parts and will fit and function on the equipment for which these are intended for and confirm to performance guarantee as per OEM standards.

Supplier has to render technical support & services to ensure fitment, proper usage, maintenance and satisfactory performance of supplied spares. Further supplier has to ensure quarterly visit of their service personnel for smooth functioning of the supplied items.

- viii) Delivery: Within 6 months from the date of supply order.
- ix) **Inspection** a certificate to be submitted by the supplier that materials under supply shall be of the best quality and workman ship and shall be in accordance with the specifications laid down in the supply order. Final inspection will be carried out at consignee ends
- x) Submission of bills
  - A. Following documents shall be submitted to the consignee
    - (i). Consignment Note
    - (ii). Challan
    - (iii). One copy of the bill
    - (iv). Warranty/ Guarantee certificate/Inspection report wherever required
    - (v). Any other document specified in the order
  - B. Following documents shall be submitted to the Paying Authority
    - (i). 100% bill in triplicate duly pre-receipted and stamped.
    - (ii). Excise duty documentary evidence wherever mentioned
    - (iii). Copy of the consignment note/warranty /Guarantee certificate/ copy of the inspection note wherever required.
    - (iv). Any other documents specified in the order.
- xi) Payment terms : 100 % payment will be made within 21 days of receipt and acceptance of materials or bills whichever is later at consignee's end
- xii) Mode of transport : By road on freight paid basis.
- xiii) Security deposit –Exempted
- xiv) Price fall Clause and LD clause applicable as per RC.
- xv) Lowest Price Certificate
