Dear Sirs,

With reference to the above, we for and on behalf of BCCL hereby conclude rate contract for a period of 02 years on you for supply of various type of leaf springs as per the enclosed annexure along with the price details at the following terms and conditions. The Annual Off take of the rate contract will be Rs. 6 Lakhs with duration of Rate Contract for a period of Two Years from the date of issue of R/C i. e from 19.01.2012 to 18.01.2014..Total Off Take for two years will be Rs.12.00 Lakhs.You will not supply Spring Leaves in Excess of the annual off take without prior approval from H.Q.

**1.Scope of supply:-Various type of leaf springs with following Technical Specifications**

Laminated steel spring of semi-elliptical section finally heat treated. The leaves are held together by a Central bolt and are prevented from lateral shifting by clips.

The leaf spring shall conform to the IS specification IS-1135-1973,.

**Material** :The steel confirmation to be designation of 50 Cr 1,50 Cr 1 V23,55S12 Mn90 and 65-S17 of IS 1570-1961.Any other spring steel having similar hardness, toughness and physical proportion are considered suitable for manufacturing of leaf spring as specified in IS:-1570-1961

**Other Features.**

- (a) Leaf spring should be as per general drawing of leaf spring assembly as per IS-1135-1973.
- (b) Clips and central bolts:- It will be provided by the manufacturer as suitable for leaf spring. Rebound alignment clips shall be provided on leaf spring
- (c) The leaf spring shall be protected against corrosion either by suitable rust inhibiting fluid.

## TERMS & CONDITIONS:

1. Prices: FIRM and FOR destination basis except Govt. taxes & duties which shall be paid extra as applicable at the time of dispatch subject to documentary evidence, within the specified delivery period. The Firm will certify on the body of each bill that the prices charged are the lowest and same are applicable to other Govt /Public Sector Undertakings ,including CIL and its Subsidiaries.
- 2.VAT:- VAT will be paid extra as applicable . Present rate of VAT is @10%.
- 3.Trade Marking :- “Ajay” along with year of manufacturing on each Spring Leaf.
4. Payment Terms: 100% within 21 days of receipt and acceptance of the materials by the consignee or from the date of receipt of Bills, whichever is later.
- 5.Packing&Forwarding: Inclusive.
6. Freight & Insurance : Nil
- 7.Excise Duty & Cess: Nil. If applicable ,the same will be borne by the firm.

**DELIVERY SCHEDULE:--**Within 30 to 60 days from the date of receipt of order against R/C.

### **NOTE : Safe arrival of materials shall be your responsibility.**

7. Security Money :- Firm being ancillary to BCCL not applicable.
8. Inspection – Final inspection shall be carried out at the consignee end after receipt of materials.
9. Transit Insurance – Shall be arranged and covered by you for safe arrival of the materials to the consignee end at your cost and risk.
10. PENALTY FOR FAILURE TO SUPPLY IN TIME

The delivery of stores stipulated in Purchase order shall be deemed to be of the essence of the contract and delivery of the stores must be completed by the date specified. No materials should be supplied beyond the specified delivery period, unless specific approval has been obtained from the purchaser.

In the event of failure to deliver the stores within the stipulated date/ period in accordance with the samples and/or specification mentioned in the supply order, and in the event of breach of any terms and conditions mentioned in the supply order. Bharat Coking Coal Limited reserves the right:

**a) To recover from successful tenderer, as agreed liquidated damages, a sum not less than 0.5% (half percentage) of the price of the stores which successful tenderer has not been able to supply (for this purpose part of a unit supplied will not be considered) as aforesaid for each week or part of a week during which the delivery of such stores may be in arrears limited to 10%. Where felt necessary the limit of 10% can be increased to 15% at the discretion of Head of the Materials Management Division .**

b) To purchase elsewhere, after due notice to the successful tenderer on the account and at the risk of the defaulting supplier the stores not supplied or others of a similar description without canceling the supply order in respect of consignment not yet due for supply or

c) To cancel the supply order or a portion thereof, and if so desired to purchase the store at the risk and cost of the defaulting supplier and also

d) To extend the period of delivery with or without penalty as may be considered fit and proper. The penalty , if imposed shall not be more than the agreed liquidated damages referred to in clause(a) above.

e) To encash any Bank guarantee which is available for recovery of the penalty or

f) To forfeit the security deposit full or in part.

g) Whenever under the contract a sum of money is recoverable from and payable by the supplier, BCCL shall be entitled to recover such sum by appropriating, in part or whole by deducting any sum or which at any time thereafter may be due to the successful tenderer in this or any other contract with Bharat Coking Coal Ltd. or any subsidiary of Coal India Ltd. Should this sum be not sufficient to cover the full amount recoverable, the successful tenderer shall pay BCCL on demand the remaining amount. The supplier shall not be entitled to any gain under this clause.

#### 11. PRICE FALL CLAUSE.

i) The prices charged for the stores supplied under the contract by the supplier shall in no event exceed the lowest price at which the supplier offer to sell the stores of identical description to any other organization from date of offer till completion of supply under the contract.

ii) If at any time during the said period the supplier offers lower sale price of such stores to any other organization at a price lower than the price chargeable under this contract, the supplier shall forthwith notify such reduction or sale to the consignee concerned under intimation to CGM(MM), Bharat Coking Coal Limited, Commercial Block, Level -III, Koyla Bhawan, Koyla Nagar, Dhanbad and the price payable under the contract for the stores supplied after the date of coming into force of such reduction or sale, shall stand correspondingly reduced. The above stipulated will not, however apply to exports by the supplier.

12 Submission of Bills- Pre-receipted stamped original bill for 100% value in Five copies along with delivery challan in original, Guarantee/ Warranty certificate, and other relevant documents etc should be submitted to the Paying Authority through Consignee only.

#### 13 Guarantee /Warranty –

Materials supplied should be guaranteed for a period of 12(twelve) months from the date of fitment or 18 months from the date of receipt and acceptance at consignee end whichever is earlier against any manufacturing defects / workmanship / inferior quality. Any defect observed on this account shall be attended within 07 days from the date of receipt of report and replace the materials within 21 days free of cost.

14 Packing: Consignment shall be supplied in non returnable suitable standard proper packing.

#### 15 Force Majeure Clause –

If the execution of the supply order is delayed beyond the period stipulated in the supply order as a result of out-break of hostilities, declaration of an embargo / curfew or blockade or fire, flood, acts of nature or any other contingency beyond the supplier's control due to act of God then BCCL may allow such additional time by extending the delivery period, as it considers to be justified by the circumstances of the case and its decision shall be final.

16.DDO'S :- All General Managers of the Areas of BCCL, GM(Transportation) or their authorized representatives will be the D.D.Os. to operate this rate-contract in addition to Hq. MM Division.
