4.SECURITY DEPOSIT :- Security Deposit of **Rs 254844=00** (Rs. Two lakhs fifty four thousand eight hundred forty four only), being 10% of the total off-take against this rate contract , will have to be deposited in form of DD or Bank Guarantee of any Nationalised / Scheduled Bank (Bank Guarantee valid for the period up to six months after the expiry of this Rate Contract) within 15 days from the date of receipt of this rate contract. Bank draft should be drawn in favour of "BHARAT COKING COAL LIMITED" payable at Dhanbad .In case the firm fails to deposit the same, the rate contract shall be cancelled and the case shall be processed to conclude rate contract elsewhere and performance shall be kept recorded for future dealings. The Security Deposit will be refunded on your request within 30 days of satisfactory execution of the rate contract (Execution of the contract means successful completion of supplies against orders placed by the DDOs against the rate contract). For unsatisfactory performance and/or contractual failure the Security Deposit shall be forfeited. EMD amount, wherever necessary, will be refunded on request after submission of Security Deposit .
