4.DELIVERY PERIOD:The materials shall be delivered with in 45 days from the date of the placement of supply order against the rate contract.Delivery schedule shall be reckoned from the 10th day from the date of placement of supply order and the date of receipt of materials at our stores shall be treated as the date of delivery.

5.PAYMENT TERMS:100% payment shall be made within 21 days of receipt and acceptance of the materials by the consignee or from the date of receipt of Bill by the consignee,whichever is later.The Bank and account details as per proforma duly filled in submitted by you alongwith the offer is enclosed for EFT payment.

6.CONSIGNEE: DGM(Admin),Koyla Bhawan, Dhanbad as shall be indicated in the supply order.

7.PAYING AUTHORITY: CM(F)PAY,BCCL, Koyla Bhawan .

8.SUBMISSION OF BILL:Pre-receipted stamped original bill for 100% value in four copies along with delivery challan in original,Guarantee/ Warranty certificate, and other relevant documents as indicated elsewhere in the order should be submitted to the Paying Authority through Consignee only.

9.PRICE FALL CLAUSE:

i)The prices charged for the stores supplied under the contract by the supplier shall in no event exceed the lowest price at which the supplier offer to sell the stores of identical description to any other organization from date of offer till completion of supply under the contract.




