However, such rearrangement of source and destination towards transportation of coal in an approved contract may be undertaken by area with proper justification for such change supported with approved valid lead measurement certificate. Any such change in source and destination of transportation of coal in approved contract may be done by Area management only with the approval of Area General Manager after proper financial vetting by Area Finance Manager.

- ii. If number of bids received online is found to be less than three on end date of bid submission then the following critical dates of the Tender will be extended manually at the time of bid opening as per GeM functionality for a period of four days.

- iii. Bidders will have right to modify / withdraw their bids during extended period of submission of bids as per GeM Functionality.
- iv. After extension, as stated above the tender shall be opened irrespective of available No. of bids on the extended date of opening of tender.
- v. The validity period of the tender should be decided based on the final end date of submission of bids.
- vi. The Employer reserves the right to issue corrigendum/addendum and it shall be binding on part of the Bidders.
- vii. The Company is not under any obligation to accept the lowest Bid/Bids and reserves the right to reject any or all the Bids without assigning any reason whatsoever, and also to distribute the work and allot the work/works to more than one Bidder or accept the tender in part and not in it's entirely, as its sole discretion.
- viii. The company reserves the right to extend the date of submission and opening of bid or to cancel the bid without assigning any reason whatsoever. Any addendum/corrigendum/date extension etc. in respect of above tender will be published in GeM portal only. Bidders are therefore requested to visit GeM Portal regularly to keep themselves updated.
- ix. The Company reserves its right to allow Public Enterprises purchase preference facility as admissible under prevailing policy.
